In continuation of our earlier letter dated 5th October,2021 on the captioned subject, we wish to inform you that, in respect of the Issue, the Fund Raising Committee of the Board of Directors ("Committee") of the Company at its meeting held today, i.e., 5th October,2021, approved the issue and allotment of 16,393,442 Equity Shares to 20 qualified institutional buyers at the issue price of ₹ 244.00 per Equity Share (including a premium of Rs. 242 per Equity Share), aggregating to ₹ 399.99 crores (Rupees three hundred and ninety nine crores, ninety nine lakhs only) pursuant to the Issue.

The Issue opened on 30th September,2021 and closed on 5th October,2021 and the same was intimated to you through our letters dated 30th September,2021 and 5th October,2021.

Pursuant to the allotment of Equity Shares in the Issue, the paid-up Equity Share capital of the Company stands increased to ₹ 37,74,62,604 consisting of 18,87,31,302 Equity Shares.
