

BPCL states at top vacancies as it looks for pvt investors

CMD D Rajkumar and director (refineries) R Ramchandran to retire on Aug 31

New Delhi, August 17

A state-run Bharat Petroleum Corporation (BPCL) inches closer to disinvestment, the company is starting at vacant top positions.

Two of the top executives in the board — Chairman and Managing Director (CMD) D Rajkumar and Director (Refineries) R Ramchandran — are set to retire on August 31.

The Public Enterprises Selection Board (PESB) had come out with job notifications for filling both the posts in August 2019.


