इंदौर कोर्ट में गैंगरेप की फाइल तीन जजों की ऑर्डरशीट गायब

धार से हथियार लाकर इंदौर में बेचते पकड़ाए

दो थानों में धराए तीन पिस्टलबाज

गाड़ियों के कांच फोड़ने वाले पकड़ाए

इंदौर। खजराणा पुलिस ने क्षेत्र में गाड़ियों के कांच फोड़ने वाले दो बदमाशों को पकड़ा है। एक बदमाश पर पहले से ही कई मामले दर्ज हैं। नये की हालत में उन्होंने तोड़फोड़ की थी। खजराणा थाना प्रभारी दिनेश वर्मा के अनुसार पकड़े गए आरोपियों के नाम साजिद पिता अमजद और फरदौन पिता रिजवान सैलानी निवासी तजीम नगर है। दरअसल बीती रात एक मैजिक में सो रहे ड्राइवर को आरोपियों ने उड़ी बाजी करते हुए मारपीट की थी। उसकी मैजिक गाड़ी भी फोड़ दी थी। पिछले कुछ दिनों से खजराणा इलाके में गाड़ियां फोड़ने की शिकायतें पुलिस को मिल रही थी। पुलिस ने मामले में मुखबिर से मिली सूचना के आधार पर दोनों बदमाशों को पकड़ा। पकड़े गए आरोपी बदमाश प्रवृत्ति के हैं। आरोपी फरदौन पर पहले से पांच प्रकरण दर्ज हैं।

युवक ने अप्राकृतिक कृत्य किया

इंदौर। बाणगंगा इलाके में रहने वाले 45 साल के एक व्यक्ति के साथ उसकी आधी उम्र के युवक ने अप्राकृतिक कृत्य किया है। दोनों में दोस्ती है। फरियादी का कहना है कि आरोपी पहले मजाक में छेड़छाड़ किया करता था। घटना वाली रात वह गर्मी की वजह से कमरे का दरवाजा खोल कर सो रहा था तभी आरोपी ने आकर उसके साथ जोर जबरदस्ती की। बाणगंगा थाने में पदस्थ सब इंसपेक्टर राजेश साहनी के अनुसार आरोपी का नाम शुभम उर्फ कट्टू मैथवी निवासी कुमाय खाड़ी है। उसके खिलाफ राजा बाग कॉलोनी में रहने वाले 45 साल के एक व्यक्ति ने अप्राकृतिक कृत्य और मारपीट का मामला दर्ज करवाया है। आरोपी अंटी चालक है। फरियादी से उसकी दोस्ती थी। फरियादी ने पुलिस को बताया कि आरोपी कई बार उससे गलत तरह की मजाक करता था, लेकिन उसने कभी उसे गंभीरता से नहीं लिया।

मदरसा संचालक के खिलाफ रेप का केस

इंदौर। चंदननगर पुलिस ने एक मदरसा संचालक के खिलाफ रेप का मामला दर्ज किया है। वहीं पर पढ़ाने वाली एक तलाकशुदा महिला को आरोपी ने शादी का झांसा देकर हवस का शिकार बनाया था। पुलिस के अनुसार आरोपी का नाम उस्मान शेख निवासी स्कीम नंबर 71 है। आरोपी क्षेत्र में ही एक मदरसा स्कूल का संचालक करता है। पीड़िता वहीं पर पढ़ाती है। वह तलाकशुदा महिला है। आरोपी ने उनसे शादी का झांसा दिया और उनके साथ शारीरिक संबंध बनाए। आरोपी ने लगभग 1 साल तक उनका दैहिक रोषण किया था। पीड़िता ने शादी का दबाव बनाया तो आरोपी ने कहा कि उसकी बेटी की शादी के बाद वह उससे निकाह कर लेगा। इसके बाद आरोपी ने महिला से शादी से इन्कार कर दिया। पीड़िता ने अब मामले में पुलिस से गुहार लगाई है।

फाइल चोरी का ऐसे हुआ खुलासा

आरोपियों द्वारा हाई कोर्ट में पेय फाइल में जिला कोर्ट की गैंग रेप की संपूर्ण न्यायालयीन फाइल को धोखे से चुरा कर उसकी अप्रामाणिकता को भी बनाकर हाई कोर्ट में अर्जी खारिज करने को लेकर पेश की। इसकी जानकारी हाई कोर्ट से नोटिस के साथ लगे दस्तावेजों से पीड़िता को प्राप्त हुई तो पीड़िता ने मध्य प्रदेश हाई कोर्ट के चीफ जस्टिस, सहित इंदौर हाई कोर्ट में शिकायत दायिका पेश कर आरोपियों की करतूत को बरों में बताया। जिसके बाद जिला न्यायाधीश ने जांच रिपोर्ट में यह पाया कि आरोपियों ने न्यायालय से दस्तावेज चुराए, और धोखाधड़ी कर उक्त दस्तावेज माननीय उच्च न्यायालय के प्रकरण में लगाए हैं। इस मामले की रिपोर्ट बनाकर डीजे को दी गई है। जो आरोपियों पर केस दर्ज करने को लेकर संज्ञान लेंगे।

सबूत पीड़िता को सौंप गया है तो कंपनी के लोगों ने उक्त सबूत पीड़िता से जोर जबरदस्ती से हासिल करने की कोशिश की। इसमें सफल नहीं होने पर पीड़िता को खंडवा से इंदौर मधुमिलन चौराहे के पास स्थित होटल सिमरन में बुलाया और वहां हरपाल सिंग उर्फ मोनू भाटिया, अभिमन्यु तिवारी, इंदरजीत सिंह, सुशील विश्वासी ने गैंगरेप किया। जिसे लेकर थाना ग्वालटोली में भी गैंगरेप की

धारओ में केस दर्ज हो गया।

पीड़िता ने पेश की थी दायिका

जांच अधिकारी द्वारा पीड़िता के पास मौजूद भ्रष्टाचार के लेजर जब्त नहीं करने, निष्पक्ष विवेचना नहीं करने, अन्य गंभीर धाराओं का इजाफा नहीं करने, सबूतों को मिटाने से परेशान होकर पीड़िता ने जिला कोर्ट इंदौर में अमन सिंह भूरिया एसीजेएम की कोर्ट में अपने वकील के माध्यम से अलग से एक दायिका पेश की, जिसमें कोर्ट ने आरोपी गणों के विरुद्ध मछलियों के बीजों की हेराफेरी कर लाखों रुपए की राजस्व हानि करने, घोटाळा करने, सबूत मिटाने को लेकर अलग से एक एफआईआर धारा 420, 467, 471, 120 बी, 201 आईपीसी में दर्ज करने के आदेश थाना छोटी ग्वालटोली को दिए थे।

इंदौर। शहर और गांव के 2 थानों की पुलिस ने कट्टे पिस्टल के साथ तीन बदमाशों को पकड़ा है। पकड़ाए आरोपियों ने कबूला है कि वह धार से हथियार लाकर इंदौर में बेचते हैं। पुलिस अब उस सिकलींग को भी ढूंढ रही है जिससे हथियार खरीदे गए थे। राऊ थाना प्रभारी रघुवंशी के अनुसार पकड़े गए आरोपियों के नाम शाहरुख उर्फ अजहर पिता शब्बीर खान निवासी देपालपुर और उमर उर्फ फारुख पिता जुम्मा खान निवासी देपालपुर है। दोनों के पास से दो देशी कट्टे, एक देशी पिस्टल और दो जिंदा कारतूस जब्त किए गए हैं। दरअसल राऊ पीथम्पूर रोड पर चेकिंग के दौरान आरोपियों को पुलिस ने रोका। उनकी तलाशी ली तो कट्टे पिस्टल मिले थे। पछताछ में आरोपियों ने बताया कि धार के नजदीक सिकलींग जालम सिंह से वह हथियार लेकर आते हैं और इंदौर में सप्लाई करते हैं। उन्होंने कई बदमाशों को हथियार बेचे हैं। पुलिस हथियार खरीदने वालों के साथ ही जालम सिंह की भी तलाश कर रही है। इसी तरह अवैध पिस्टल पकड़ने की कार्रवाई शिप्रा पुलिस ने भी की है। टीआई महोदया के अनुसार पकड़े गए आरोपी का नाम विशाल उर्फ विशु ठाकुर निवासी कदवाली खुर्द थाना शिप्रा है।

रिक्शा पलटने से तीन महिलाएं घायल

इंदौर। एकआयजी थाने के नजदीक कल रात हुए एक हादसे में तीन महिलाएं घायल हो गईं। तीनों कथा स्थल से लौट रही थी। मिली जानकारी के अनुसार घायल महिलाओं के नाम सुमन पति सुरेश, कोशल्या पति रमेश और उषा पति महेश तीनों निवासी पश्चिमी नगर है। उन्होंने बताया कि वह कथा सुनकर रात को आंटे से घर जा रही थीं।

तीन कोचिंग संस्थानों में आग

कैफे से शुरू हुई आग में बुक स्टॉल और कोचिंग क्लासेस स्वाहा

इंदौर। इंदौर के भंवरकुआं इलाके में शुक्रवार को बड़ी आगजनी की घटना हो गई। यहां एक कैफे से शुरू हुई आग ने किताब की दुकान और तीन कोचिंग क्लासेस को चपेट में ले लिया। मौके पर पहुंची फायर ब्रिगेड ने काफी मशकत के बाद आग पर काबू किया। छुट्टियों के कारण कोचिंग सेंटर बंद होने से बड़ा हादसा टल गया। फायर ब्रिगेड के मुताबिक सुबह करीब सात बजे के लगभग यहां आग की शुरूआत हुई थी। कंट्रोल रूम पर सूचना मिलने के बाद मौके पर फायर फाइटरों को रवाना किया गया। तब तक आग ने विकराल रूप ले लिया था। बताया जाता है कि जिस कैफे से आग की शुरूआत हुई थी। उसकी दीवार से सटी हुई वी श्री नाम की किताबों की दुकान है। इसके कारण आग काफी बढ़ गई। यहां दो हिस्सों में लकड़ी की अलमारी में किताबें पूरी तरह से जलकर खाक हो गईं।

फर्नीचर सहित पूरा सामान जला

फायर ब्रिगेड के मुताबिक इसके बाद आग की लपटों ने विष्णु गुप्ता

कोचिंग क्लासेस और आग्नेय इंस्ट्र्यूट सहित अन्य कोचिंग को भी चपेट में ले लिया। जिसमें आग से काफी नुकसान हो गया। यहां भी अंदर किताबों और फर्नीचर रखे होने से आग काफी अंदर तक फैल गई। फायर ब्रिगेड के मुताबिक आग बुझाने में करीब 12 टैंकर से अधिक पानी लगा। वहीं नगर निगम के कुछ टैंकर अलग से बुलाए गए। कोचिंग संचालकों ने बताया कि छुट्टियों के चलते अभी नई बैच प्रारंभ नहीं हुई। वही एक कोचिंग में बैच करीब सात बजे शुरू होना था। लेकिन आग के चलते बच्चे अंदर नहीं पहुंचे।

हॉस्टल संचालक ने की छात्रा से अश्लील हरकत

इंदौर। शहर में पढ़ाई करने आई छात्रा के साथ उसके हॉस्टल मालिक ने अश्लील हरकत की। पुलिस ने आरोपी के खिलाफ केस दर्ज किया है। मामला चंदन नगर थाना क्षेत्र के स्क्रीम नंबर 71 में स्थित दादी जी पीजी हॉस्टल का है। आरोपी का नाम रोशन सिंह राजावत है। दरअसल उज्जैन जिले की एक लड़की इंदौर में बीएससी की पढ़ाई कर रही

है। वह दादी जी पीजी हॉस्टल में पेइंग गेस्ट के रूप में रहती है। उसने पुलिस को बताया कि बीती रात को नींद नहीं आ रही थी। तब वह बाहर खड़ी थी। उसी दौरान मकान मालिक रोशन सिंह राजावत उसके पास आया और गलत हरकत की। पीड़िता के शोर मचाने पर आरोपी वहां से भाग गया। इसी तरह छेड़छाड़ का एक और मामला खजराणा पुलिस ने

आरोपी राजा और राजवीर चौहान पिता राधेश्याम निवासी जुगन नगर खजराणा के खिलाफ दर्ज किया है। एक नाबालिग लड़की ने उसके खिलाफ केस दर्ज करवाया है। पीड़िता ने बताया कि आरोपी लगातार उसका पीछ करता है। कल वह साईं धाम कॉलोनी में किसी काम से गई थी तो आरोपी ने सर्राह हाथ पकड़कर उसे गलत हरकत की है।

श्मशान को बना लिया था टिकाना

अपने ही खून से तिलक लगाने वाला ढोंगी कहता मैं देवी का मत्त हूं

इंदौर। इंदौर के समीप राऊ में दो पुलिस कर्मियों पर हमला कर फरार हुए टुक ड्राइवर को पुलिस ने सतना से गिरफ्तार किया है। आरोपी आठ माह से पुलिस को चकमा दे रहा था। उस पर दस हजार रुपए का इनाम घोषित था। इंदौर में हमला करने के बाद वह उज्जैन के श्मशान घाट में छुपकर रहने लगा। इसके बाद संत का चोला ओढ़ कर मंदिरों में घूमा। यहां काफी समय रहने के बाद गुवाहाटी, अयोध्या, असम, मथुरा सहित कई धार्मिक स्थानों में घूमता रहा। आरोपी खुद को देवी का भक्त बताता था। वह देवी को अपने खून का तिलक लगाता था। घटना वाले दिन भी वह देवी को अपना खून अर्पित कर रहा था। लेकिन उसे लोगों ने रोक टोक कर दी। जिसके चलते वह उत्तेजित हो गया था। उज्जैन में भी वह श्मशान में देवी को खून से तिलक लगाता था।

होटल-ढाबों में की तलाश

पुलिस ने आरोपी की होटल-ढाबों में तलाश की। लेकिन वह नहीं मिला। करीब आठ माह तक पुलिस अलग-अलग लोकेशन मिलने पर महाराष्ट्र और गुजरात में भी उसे तलाशती रही। लेकिन आरोपी की जानकारी नहीं लगी। इसके बाद आरोपी के फोटो धर्मशाला और बस स्टैंड के आसपास चला कर 10 हजार के इनाम की घोषणा भी की गई। लेकिन शिवनंदन की जानकारी नहीं लगी।

टीआई नरेन्द्र रघुवंशी के मुताबिक 13 सितंबर 2021 को राऊ थाने के पुलिसकर्मियों को गलत के दौरान सूचना मिली थी कि नखराली ढाणों के पास एक बदमाशा चाकू लहरा रहा है। जब पुलिसकर्मियों उसे पकड़ने पहुंचे तो उन पर हमला कर खेतों के रास्ते फरार हो गया था। पुलिस ने दो दिन तक इंदौर के आसपास के डेयों में उसकी तलाश की। लेकिन वह नहीं मिला। प्रारंभिक जानकारी में आरोपी का नाम शिवनंदन पुत्र रामचरण पटेल निवासी ग्राम इटमा, सतना पता चला था। आरोपी टुक चालक है। पुलिस ने उसके मालिक की जानकारी निकाली।

Earlier on September 6, 2021, Bansilal Gaur had demolished the house. He later rebuilt it. For a few days, threats to vacate the house began. Complaint was lodged in this regard in the public hearing. Complainant Anil Solanki said, 'Lakhan Rathore's and my house are nearby. Around 10 am on Thursday, Bansilal's sons Manoj, Vicky and Dinesh came in front of our house with their JCB (MP-

09 GE 3847) and said that the house is theirs. When we opposed they started beating us up. Two other persons also joined them. They ransacked my house by running JCB on it. They threatened that if I complain to the police, my house will be demolished. The miscreants came with swords and other weapons. After the incident, Tehsildar Abhishek Sharma reached the spot and demarcated the land. Police have registered a case against accused Manoj, Vicky and Dinesh under different sections of the Indian Penal Code (IPC).

FIR against illegal colony in Mhow

FP NEWS SERVICE Mhow An FIR has been registered by the administration against Vindhayachal Colony being developed illegally in village Bhagora Tehsil Mhow. Vindhayachal Colony Land Khasra No. 549/1, 550/1, 550/2, 550/3, 550/4, 550/5, 552/4 Total area 6.030 hectares Land owner Abdul Rashid, Hemlata Khatik, Gulab Rajoura, Atmaram Mali, Dayaram Mali, Krishnabai, Shankarlal and Gopal in association with a person named Lokesh Verma was being developed. All the land owners had au-

thorised Lokesh Verma through power of attorney to sell the plots to customers by cutting small plots of their land. The plot was sold by Lokesh Verma to 77 people. During investi-

gation it was found that none of the land owners including Lokesh Verma had coloniser license, colony layout and colony development permission approved by TNCP. Without these regular permission, only on the basis of diversion, the construction of colonies and purchase of plots was prevalent. Therefore, a complete ban was imposed on the construction work and sale of plots by the administration and MP against the colonisers. An FIR was registered in Kishanganj police station under Section 61-D of the Panchayat Raj and Village Swaraj Act.

RAJASTHANI STYLE TEMPLE FULL OF GRANDEUR, BEAUTY

GOPAL MANDIR WEARS A NEW LOOK; OVER ₹4CR SPENT

BHARAT DHOLI Mhow Gopal Mandir occupies a place among the main temples of the city. It is not only a temple, but has also been the centre of consciousness, culture and religious activities of the city. Before independence, it was an education and medicine centre. The temple started in 1882. It took 12 years to be constructed. The entire construction was done in three phases. In the first phase, the temple was prepared, while in the second and third, a dispensary and school came up respectively.

The school was established in the year 1907. From the very beginning, Gopal Mandir was operated jointly by the Maheshwari Samaj and Marwari Agarwal Samaj. People of both the societies are natives of Rajasthan. From there they came to Mau. About 150 families were in Mau. Most of these families used to live in tents and did their business in Singh Street from the very beginning. Land was given to the families and houses were constructed there. Then the huge Gopal Mandir came up. Before independence, the city was the cen-

tered by many social activities. Many meetings were organised in the enclosure. To address these, from time to time, Vidarbha Kesari Brijlal Biyani, played an important role in the freedom struggle. Programmes were organised for encouraging speeches of Jammalal Bajaj, Arjun Lal Sethi, Seth Govind Das etc. In this enclosure plays promoting national sentiment were also staged. Many programmes were organised in the enclosure for a long time. The branch of Rashtriya Swayamsevak Sangh (RSS)

was also planned in the evening for many years. After the construction of Gopal Mandir, a school and a dispensary were built in its premises. At that time the population of Mhow was hardly 20,000. The facilities related to medical education in the city were very

limited. In such a situation, schools and dispensaries began in the society. All arrangements were free of cost in the school and dispensary. After becoming the centre for medicine, the dispensary closed down only about 45 years ago. About Gopal Mandir: The arrangement of food for the poor every morning was going on for many decades before independence. There will be fewer such temples here for public interest. For many decades, this arrangement has been given free of cost. Now after 140 years, the Gopal

Mandir has been newly built. More than Rs 4 crore has been spent in giving it a new avatar. The magnificence of the new temple has increased its beauty. Not only for the citizens of Mhow, but also for travellers and devotees coming from outside, it will be a major centre of attraction.

On the upper floor of the temple, facilities are there for the devotees to stay. The vastness of the temple can be estimated from this. In the temple hundreds of devotees can sing hymns, do kirtan, perform aarti collectively and can enjoy religious discourse. The marble design and the en-

tire work has been done under the guidance of Khurshid Bhai and Narendra Sompura. Both of them are residents of Rajasthan. The latter's family is associated with many laurels. Painting of the temple was done by Tejpal Singh of Kuchaman City, Rajasthan.
