Pursuant to **SEBI Circular No. SEBI/HO/CFD/CMD1/CIR/P/2020/84** dated May 20, 2020 and Regulation 30 of SEBI (Listing and Disclosure Requirements) Regulations, 2015, we wish to inform you that in view of the CoVID-19 pandemic, the operations of the company were disrupted and its Registered Office and plants were locked down as per the directives applicable to them. However the impact of lockdown of operations cannot be assessed at this point of time.

We would further like to inform you that as per the extant guidelines issued by the Government of India/ State Government(s)/ Local Authority and after securing permission from the Local Government Authorities, the Company has resumed partial operations at its manufacturing unit at Mandideep, Bhopal, Madhya Pradesh and Parwanoo, Himachal Pradesh with minimum staff and necessary precautionary measures as per the Government Rules.

The Company is complying with all the conditions imposed by the authorities and undertaking the necessary measures for safeguarding health of the workforce. The Company will continue its efforts towards achieving normalized level of operations, depending upon prevailing situation and the Government directives.

The Company has reduced its fixed expenses and expecting to do better business from the second quarter of the financial year 2020-21 and expecting normalcy in the situation of CoVID-19.
