Vidushi Thapa, head of merchandising, PUMA India, says that track suits have emerged as the "it" look for Indian consumers across segments. "We are witnessing an uptick in the sale of track suits as it has gained immense consumer appeal driven by influences of popular series as well as trending anti-fit and oversized styles for airport looks by celebrities and the overall rise of athleisure," she says adding that the brand has doubled their investment in tracksuits to cater to this growing need this year. "Matching sets have been performing well for us. There is a huge demand for colours such as olive, black, navy blue and charcoal," adds Thapa.

Like the show puts everyone on equal footing, it's not just big players who are seeing a surge in sales of matching sets. Homegrown brands are reaping the benefits of the international show's popularity. Sunishka Goenka Khetan, creative director of Myriad Activewear shares, says "After the hype of Squid Games, we have seen a rise of trending matching coordinates. Matching sets have boomed compared with selling as separates over the last few months." Amita Singh, brand re-

presentative, Sassafras, echoes this and says, "Co-ord sets are really doing well. Black has usually been a long time favourite but we have also seen an increase in khaki and neon shades over the past month." Sangeet Paryani - founder, Superkicks India, adds that their sale of classic Vans slip on shoes (as seen on the show) have also been higher than usual.

This isn't the first time, however, that pop culture has made a mark on closets. Vedant Lamba, founder of The Mainstreet Marketplace, shares: "A relevant example to our business would be the Michael Jordan documentary that was released in 2020 titled 'The Last Dance'. We saw a huge spike in the prices of several shoes. Plenty of them even doubled — and it led to an unquestioned dominance of Jordan Brand over Yeezy in the sneaker industry through 2020."

Khetan says 'Money Heist' was another international show that influenced buying patterns, and observes that "millennials and Gen Z are known to be experimental with their style".

ELECTRIC IN FOCUS
