# Give Muslims Extra Land Outside Ram Mandir Site

Spiritual leader Sadhguru Jaggi Vasudev expressed his candid views on building the Ram Mandir, doing away with farm loan waivers and why Sabarimala is not a gender rights issue in an interview with Kumar Anshuman. Excerpts:



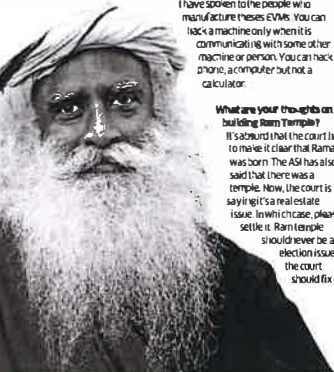
**What are your views on scrapping farm loan waivers?**  
The farmer needs intervention but loan waiver is not the right thing to do in the 1970s when bank nationalisation happened one promise was that banks will lend to the poor. By saying you don't have to return the loan, you are demoralising the whole population. Farm loan waivers eventually take farmers back into the hands of money lenders. We have seen 50 years of making [finance] available to the rural people. If you set a culture of not returning money, how long will one give you money?

**What do you think of the Centre's decision to directly transfer cash support to a farmer's bank account?**  
Direct cash transfer is very good because earlier the anti-lemas were not reaching the farmer. Jan Dhan account scheme is one of the most revolutionary programmes. ₹6,000 is not a small amount for an impoverished person.

**You have been very supportive of GST. But there is a view that it has hurt small businesses. GST is one of the most significant economic steps taken in last few years. It has affected small business, but India**

wants to do big business, this change was needed. If you don't make such changes which hurt a little bit, we



will always remain a small business. Political motives have been attributed to your statement that there have been no bomb blasts in the last four years... It only said that in the last four years one good thing is that none of the major cities has witnessed a bomb blast. It has happened in Kashmir and in the Red (Naxal) corridors but when is the best time has happened in a major urban centre? I said thank to our security forces and somebody made it up like thanks to the BJP.

**Do you have a view on EVMs?**  
EVM is a miracle. People are just being bad losers. When they win they speak one language and when they lose, they speak another. Everywhere we are trying to do paperless transaction, but when it comes to polling, you want to go back to the paper ballot so that you can fix it and change it and do all kinds of things which is not possible with EVMs. I have spoken to the people who manufacture these EVMs. You can't lock a machine only when it's communicating with some other machine or person. You can hack a phone, a computer but not a calculator.

**What are your thoughts on building Ram Temple?**  
It's absurd that the court has to make it clear that Rama was born. The ASI has also said that there was a temple. Now, the court is saying it's a real estate issue. In which case, please settle it. Ram temple should never be an election issue, the court should fix it.

**Is the government's call to have reservation for economically weaker sections a step in the right direction?**  
The time has come for the reservation for economically weaker sections. The only thing the people say is that there is always some or the other election going on in the country.

for good this time. Just build the temple and be done with it. Out of entire land, the disputed land is only about 2.7 acres. If one third of it belongs to Muslims, ideally they would be given their share with extra 2.7 acres outside the disputed land. In that way we resolve our land disputes? The emotion is on the Hindu side because they were born there so such emotion on the Muslim side. The court must settle it before the election.

**What do you think of the court's role in the Sabarimala matter?**  
The Sabarimala issue has got nothing to do with gender discrimination. There are more Devi temples than any other deity. The temple is not a place of prayer. You are supposed to go there for darshan. But Sabarimala is an Akal Bramchari. It is his personal abode, his bedroom. Why do you want to go there? The court should not decide what should happen in a temple.

New Delhi: The Congress manifesto for the general election is likely to contain a number of promises aimed at mobilising the youth vote.

The bouquet is likely to include 100-day guaranteed jobs for graduate youths in urban areas, free education for girls from Kindergarten to post-graduation, zero dropouts for lack of funds, a Students' Rights Commission and assured representation of youths in local bodies.

In line with party chief Rahul Gandhi's pledges, it has decided to link a minimum income guarantee scheme to the job scheme for urban youths. Congress may use it to focus schemes similar to the Madhya Pradesh...
