Suvendu's brother, GCPA leader get central security cover

New Delhi: The Centre has sanctioned a 'Z' category armed security cover to Soumendu Adhikari, the younger brother of BJP's Suvendu Adhikari, who is the leader of opposition in the West Bengal Assembly, officials said on Thursday.

A lower category of 'Y+' secuhity has also been extended to Greater Cooch Behar People's Association (GCPA) leader Ananta Maharaj, who has a considerable following among the Rajbangshi community, they added.

The Union Home Ministry has sanctioned the armed VIP security cover to the two and has asked the Central Reserve Police Force (CRPF) to undertake the task, the officials said. This security cover has been extended following a recommendation made by central intelligence and security agencies that the two leaders require proper protection, they said. PTI

Blast at J&K BJP leader's house

Jammu: A local BJP leader in Jammu and Kashmir's Rajouri town was injured in a mysterious explosion on Thursday night at his residence. Jasbir Singh and three members of his family were taken to the Rajouri district hospi--tal with injuries, sources said.

The explosion led to panic in Rajouri, with people rushing to the hospital or towards the Khandli Bridge area, where Singh's residence is located. Police have corrdoned the area, sources said.

Quoting initial reports, a senior police officer said that the explosion took place on the roof of the house. However, the cause of the explosion is yet to be known.

Last week, the Jammu and (Kashmir Police and security forces had killed two militants, includring a Pakistani national, in Rajouri district's Thanamandi area. ENS


