Sirs/ महोदय,

In continuation to our earlier letter dated 05.10.2023 and in compliance to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the relevant information in respect of Teesta-VI HE Project, Sikkim (500 MW) being executed by Lanco Teesta Hydro Power Limited, a Wholly Owned Subsidiary of NHPC Limited, which was affected due to flash flood in Teesta Basin on October 4, 2023 is as under:

- Expected quantum of loss/ damage caused due to the natural calamity/ other force majeure events: **Rs. 233.56 crore approx.**
- Whether loss/ damage covered by insurance or not, including amount: **Yes, all assets/ works of Teesta-VI HE Project are insured under Construction All Risk (CAR) Policy, subject to excess clause and loss limit.**
- Insurance amount claimed and realized by the listed entity for the loss/ damage – **NIL (as on date). However, formal claim shall be lodged and amount for damage/ loss would be realised in due course of time as per CAR policy.**
- Details of steps taken to restore normalcy and the impact of the natural calamity/ other force majeure events on production or service, financials of the entity : **Assessment is being done and restoration works are under progress. It is anticipated that there will be time delay of atleast 6 months and consequent cost-overrun of the Project.**
