

Move to ensure PSBs explore all avenues of realising their loans

New Delhi: The government has asked state-run banks to look out for insolvency cases that may also require proceedings to be initiated against personal guarantors of corporate debtors in the Natio-

nal Company Law Tribunal. This is to ensure that banks explore all avenues when realising loans. Rules empowering creditors to file insolvency applications against personal guarantors came into effect in December. "Banks may consider putting in place a mechanism for monitoring the cases which may require initiation of individual insolvency process before NCLT against personal guarantors to corporate



debtors," the department of financial services said in an advisory dated August 26.

The department also asked banks to consider setting up an IT system to collate data regarding personal guarantors to corporate debtors in all such cases for requisite followup and "consequential action." The government suspended sections 7,9 and 10 of the Insolvency & Bankruptcy Code for six months starting March 25 to prevent borrowers from being dragged into insolvency in the wake of Covid-19. Section 7 allows a financial cre-

ditor to initiate a corporate insolvency resolution process against a corporate debtor, section 9 provides for application of insolvency by an operational creditor, and Section 10 is for initiation of insolvency resolution proceedings by a corporate applicant.

The government will take a call at September end on whether the suspension needs to be extended. Experts said the government appears to be attempting to nucle lenders to invoke personal guarantees and initiate IBC proceedings againstguarantors whenever possible.

Hit Crop Output

Pune: Persistent bursts of tor rential rain, particularly in central and western India, are threatening crop output which is so far expected to rise to a new record and make agriculture the best performer in the Covid-hit economy. The southwest monsoon has


turned vigorous in August after a deficient July, raising fears of solvent floods. Rainfall this month has been 23% above normal in the country, with many parts of central and western India including Gujarat, Maharashtra and Madhya Pradesh receiving much more than average.

The current spell of heavy rain has damaged urad and soyabean in central and western India. Excess rainfall may persist as the rain-boosting La Nina forecast is expected in the weeks ahead.

"All talk of a massive crop of an email response to ET. soybean and groundnut now

seems to be getting moderated with the rains showing no signs of relenting," said Atul Chaturvedi, president of trade body Solvent Extractors' Association, which expects 10-12% croploss.

Ratings agency Crisil says the possibility

"I cannot get into details at this point, but I can assure you that we are developing solutions that will be in the interest of users, creators, parmers and employees, "he said. In a statement, TikTok said, "We appreciate that the political dynamics of the last few months have significantly changed what the scope of Kevin's role would be going forward, and fully respect his decision." Vanessa Pappas, general manager of TikTok in North America, will take over as the interim global head of the company.




