TO AMEND ARTICLES OF ASSOCIATION OF THE COMPANY TO ENABLE ISSUANCE OF STOCK OPTIONS/ SHARE WARRANTS

To consider and if thought fit, to pass, with or without modification(s), the following resolution as a **Special Resolution**:

“RESOLVED THAT pursuant to the provisions of Section 14 and any other applicable provisions of the Companies Act, 2013 (the ‘Act’) read with Rules framed there under, including any statutory modification(s) thereto or re-enactment(s) thereof for the time being in force and any other approvals as may be necessary, consent of the members of the Company be and is hereby accorded to amend the Articles of Association of the Company by insertion of the following Clause as Clause 37A (Immediately following existing Clause 37 and immediately preceding existing Clause 38):

37 A. Powers to issue stock options/share warrants

Accordingly the Board/ Committee may in its discretion, with respect to any share which is fully paid, upon application in writing signed by the persons registered as holders of the share warrants and authenticated by such evidence (if any) as the Board/ Committee may from time to time require as to identify the person signing the application, and on receiving the certificate (if any) of the share warrants and the amount of the stamp duty on the share warrant and such fee as the Board/ Committee may from time to time require, issue and allot equity shares or other securities.”

23. Pursuant to the provisions of Section 72 of the Companies Act, 2013 read with the Rules made thereunder, Members may avail the facility of nomination in respect of the shares held by them. Members holding shares in physical form may avail this facility by sending a nomination, in the prescribed Form No. SH-13, to the Company's Registrar and Share Transfer Agent. Members holding shares in demat form may contact their respective Depository Participant for availing this facility.
24. Securities and Exchange Board of India (SEBI) has mandated submission of Permanent Account Number (PAN) by every participant in securities market. Members holding shares in demat form are, therefore, requested to submit PAN details to the Depository Participant with whom they have demat accounts. Members holding shares in physical form can submit their PAN details to the Company's Registrar & Share Transfer Agent, M/s. Link Intime India Private Limited, quoting their Folio number etc.
25. Pursuant to Regulation 40 of the Listing Regulations, the securities of listed companies can be transferred only in the dematerialized mode w.e.f. 1st April, 2019, except in case of transmission or transposition of securities. In this regard, SEBI has clarified by a Press Release No. 12/2019 dated 27th March, 2019, that the said amendments do not prohibit an investor from holding the shares in physical mode and the investor has the option of holding shares in physical mode even after 1st April, 2019. However, any investor who is desirous of transferring shares (which are held in physical mode) after 1st April, 2019 can do so only after the shares are dematerialized. However, requests for transfer of shares held in physical mode, as filed in Form SH-4, prior to 1st April, 2019 and returned to the investors due to deficiency in the documents, may be re-submitted for transfer even after 1st April, 2019 provided it is submitted along with the necessary documents including PAN details. In exceptional cases, the transfer of physical shares is subject to the procedural formalities as prescribed under SEBI Circular No. SEBI/HO/MIRSD/DOS3/CIR/P/2018/139 dated 6th November, 2018. In view of the above and to avail various benefits of dematerialisation, Members are advised to dematerialise the shares held by them in physical form.

EXPLANATORY STATEMENT PURSUANT TO SECTION 102(1) OF THE COMPANIES ACT, 2013

The following statement sets out all material facts relating to Special Business of the accompanying Notice dated 27th December, 2021

Item No. 1

The Company proposes to issue, subject to applicable law, stock options/ warrants that would entitle the holder to acquire, on exercise of such options/ warrants, equity shares of the Company. Accordingly, for this purpose, it is desired that an enabling/ empowering clause may be inserted in the Articles of Association to issue stock options/ share warrants.

In terms of the provisions of Sections 14 and other applicable provisions of the Companies Act, 2013, the alteration of the Articles of Association of the Company requires consent of Members of the Company by way of passing of a Special Resolution.

Each Warrant is convertible into One (1) Equity Share and the conversion can be exercised at any time during the period of Eighteen (18) months from the date of allotment of Warrants, as the case may be, on such terms and conditions as applicable, entitling the Proposed Allottees to subscribe to and be allotted the Warrants convertible into Equity Shares of the Company.
