अमेरिका और चीन के बीच व्यापार तनाव बढ़ने के साथ निवेशकों को सोने की खरीदारी में रुझान और तेज हो गया है। पीली धातु का प्राइम सोल्डर को 800 रुपये अंतरकार रिफाई 36,970 रुपये प्रति 10 ग्राम पर पहुंच गया, जो 37 हजार से ऊपर पहुंचे करेगा है।
