Set up panel on OBC quota: Madras HC to Centre

ARUN JANARDHANAN CHENNAI, JULY 27 THE MADRAS High Court on Monday directed the Centre to set up a committee to examine the issue of OBC quota in admissions to state-run medical and dental colleges under the all-India quota. The court said the committee, comprising representatives from the Centre, state and the Medical Council of India (MCI), should be constituted within three months.

NDRE, PM CARES: SC reserves order as Centre says both funds can exist

ANANTHAKRISHNAN NEW DELHI, JULY 27 THE SUPREME COURT reserved its order Monday on a petition seeking transfer of money retained in the PM CARES Fund to the National Disaster Response Fund, a plea opposed by the Centre. The petitioner alleged it was created to circumvent the National Disaster Response Fund. The court said a public charitable trust and any private individual who wants to contribute can contribute to it.

“This case is this to circumvent NDRA... This is a fraud on the Constitution. All we are saying is subject to public scrutiny,” it said. The Centre, in its affidavit filed in the matter, defended the creation of the PM CARES Fund which accepts funds for Covid relief operations and opposed the transfer of these funds to the NDRE.
