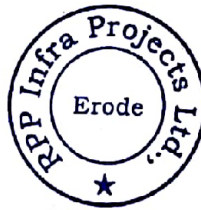

Dear Sirs,

We are pleased to accept for and on behalf of the President of India, your item rate tender for the above mentioned work for a total amount of **Rs. 37,77,32,130/- (Rupees Thirty Seven Crore Seventy Seven Lakhs Thirty Two Thousand One Hundred and Thirty only)**. You are therefore requested to start the work immediately within **15** days from date of issue of the work order as per the terms and conditions given below and also as envisaged in the tender document.

1. Prices

- The price quoted and as accepted shall be firm and no price variation during the contract period will be entertained. The item rates indicated in the schedule of quantity and the total amount are inclusive of all rates, taxes and duties. The contractor should be registered under Goods & Service Tax (GST) and GST as applicable as per the extant order on the work shall be paid by the contractor to concerned tax authorities. BARCF will not entertain any claim whatsoever in this regard.

2. Scope of Work

The work involves civil construction work for proposed DDUO Storage Building, which consist of RCC work, soil back filling, plastering etc. at BARCF, Kalpakkam. The work shall be carried out strictly as per the technical specifications, drawings, additional special condition etc., as given in the tender document.

3. Time of Completion

Time allowed for execution of the works is 24 (Twenty Four) calendar months which is reckoned from 15th day of issue of the work order or actual date of start of work whichever is earlier in accordance with these conditions shall be the essence of the contract. If the contractor commits default in commencing the work as aforesaid, Government shall without prejudice to any other right or remedy available in law, be at liberty to forfeit the Earnest Money Deposit/Performance Guarantee absolutely.

4. Agreement

A formal contract agreement for the work will be drawn up and you are required to sign the same within 15 days from the date of issue of work order. However until a formal contract agreement is signed, the tender submitted by you and the letter of acceptance will form a binding contract between us.

5. Tax Deduction at Source

- a. GST TDS as applicable will be deducted from the Running Account Bills/Final Bill and remitted to the concerned authority.
- b. Income Tax and all other taxes as applicable will also be recovered from the Running Account Bills/Final Bill and remitted to the Tax authority and similarly TDS certificate will be issued on later date.
- c. Labour cess @ 1% will also be recovered and remitted to concerned authorities.

6. Security deposit

The **Security Deposit** at 2.5 % of the gross amount of each Running Account Bill as well as Final Bill of the contractor shall be deducted till the sum deducted will amount to security deposit of 2.5% of work order value of the work.

Performance Guarantee: In addition you are requested to deposit an amount equal to 3% of the tendered value of the contract i.e. **Rs. 1,13,31,964/-** as performance guarantee either in the form of DD/FDR/Bankers Cheque of a scheduled bank drawn in favour of Pay & Accounts Officer, BARCF Kalpakkam payable at State Bank of India, Kalpakkam or in the form of a irrevocable bank guarantee from any schedule bank within 15 (fifteen) days from the date of issue of work order or actual date of commencement of work whichever is earlier. This period can be further extended at the written request of the contractor to the Engineer-in-charge for a maximum period ranging from 1 to 15 days with late fee @ 0.1% per day, of performance guarantee amount. If the contractor fails to furnish the prescribed performance guarantee within 15 days (and subject to grace period mentioned in schedule F) from the date of issue of work order or before commencement of the work, whichever is earlier, BARCF shall without prejudice to any other right or remedy, will forfeit the EMD. The Bank Guarantee shall be valid up to the entire period of contract plus 2 months with a claim period of 6 months from the date of its expiry.

Earnest money deposited along with bid shall be returned after receiving performance guarantee.

7. Payment Terms & Submission of Bill

No advance payment will be made. Running Account Bills prepared in the prescribed format shall be submitted along with Measurement Book duly approved by the Competent Authority to the Accounts Officer through the Engineer-in-Charge. EPF and ESIC (Employer's contribution in both) if applicable, shall be reimbursed by the Department after satisfying that it has been actually and genuinely paid by the contractor.

8. Free Issue Materials

Free Issue Materials as per the Schedule 'B' shall be issued by the Department

9. Extension of Time

Normally no extension of time beyond the scheduled period for completion of the work will be granted except where events constituting force majeure, as provided in the contract, have occurred or the terms and conditions included such a provision for other reasons.

10. Engineer-in-Charge

Shri. Sabuj Mondal, TO/E, INRPK shall be the Engineer-in-Charge for the above work. The contractor or his authorized representative may contact the Engineer in-Charge for further details and execution of the work.

11. Liquidated Damage

This contract contains a provision for recovery of liquidated damages for defaults on the part of the contractor.

12. Labour

You shall comply with various provisions of the contract labour (Regulations & Abolition) Act, 1970 and rules framed there under especially obtaining license before commencing the work, payment of wages, display notice at the place of work showing rates of wages, wage period, date of payment of wages in the presence of our representative name and complete address of the Inspector, abstract of rules and regulations in English, Hindi and Marathi, providing amenities etc. You shall send copies of the same to the inspector and the Engineer in Charge of the work so that he can ensure the presence of an authorized representative at the time and place of disbursement of wages. You should also intimate the maximum number of labourers employed / likely to be employed by you to the Engineer in Charge of this work before commencement of the work. In case the contract labour act does not apply to your organization, you should intimate the Engineer in Charge of this work accordingly before commencing the work. Further you shall also comply with provisions of other laws such workmen's compensation act 1923, minimum wages Act 1948, EPF Act, Gratuity Act and other labour laws as applicable to your organization. In case of any failure to comply with the above provision this department shall be entitled to recover the same from your bills.

14. Transport Facilities

The contractor shall provide transport facilities for their labours engaged by them. In case they are unable to provide such transport facility, they may use the departmental transport facility for which they will be charged the cost of transport on pro-rate basis, being worked out by department. Such amount shall be deducted from their running bills on monthly basis based on the certificate of EIC.

15. Non-Subletting

The work should not be given on Sublet basis to anybody else.

16. Security Vetting

The contractor has to follow all the security regulation as applicable during the time of execution of this work.

17. Confidentiality Clause

No party shall disclose any information to any third party concerning the matters under this contract generally. In particular, any information identified as "Proprietary" in nature by the disclosing party shall be kept strictly confidential by the receiving party and shall not be disclosed to any third party without the prior written consent of the original disclosing party.

The undersigned reserves the rights to short close the contract partly or terminate the entire contract awarded as the case may be without assigning any reason thereof.
