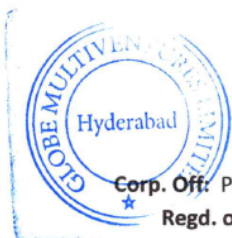

Since Mr. Satya Murthy Sivalenka along with his relatives while controlling the management of GMVL and Motitree Sales Private Limited, also holding 11.32% pre-issue holding and 23.21% post-issue holding of GMVL, he is considered to be Ultimate Beneficial Owner (UBO) of GMVL and hence, he is declared to be UBO.
