

बेकसूर सामाजिक कार्यकर्ताओं की तत्काल रिहाई का आदेश

जनसत्ता ब्यूरो नई दिल्ली, 4 अगस्त।

सुप्रीम कोर्ट ने बिहार के अरिया जिल में सामृहिक बलात्कार के एक मामले की पिछले महीने अदालती सुनवाई के दौरान व्यवधान डालने के आरोप में गिरफ्तार दो महिला सामाजिक कार्यकर्ताओं को जेल से तत्काल रिहा करने का आदेश दिया है। अदालत ने मंगलवार को बिहार सरकार को इस मामले में नोटिस भी जारी कर दिया। इसमें सरकार से पृछा है कि इन कार्यकर्ताओं के खिलाफ दर्ज पुलिस मामले को क्यों न रद्द कर दिया जाए।

न्यायमर्ति अरुण मिश्रा की अध्यक्षता वाले तीन जजों के एक खंडपीठ ने दोनों महिलाओं की याचिका पर सुनवाई करते हुए कहा कि जिस आदेश से उन्हें हिरासत में लिया गया, उसकी कतई इजाजत नहीं दी जा सकती। कल्याणी बड़ोला और तन्वी नैयर दस जुलाई को बलात्कार पीड़ित की सहायता कर रही थी जब उसे मजिस्ट्रेट के समक्ष अपना बयान दर्ज कराना था। पर 22

वर्षीय बलात्कार पीड़ित मजिस्ट्रेट के समक्ष कार्यवाही को समझ नहीं पाई और नाराज हो गई। उसका कहना था कि वह चाहती थी कि उसके हस्ताक्षर कराने से पहले मजिस्टेट उसके बयान को उसके साथ आई दोनों सामाजिक कार्यकर्ताओं को दिखा लें।

इस महिला के साथ छह जुलाई को बलात्कार हुआ था। उसकी मांग को मजिस्ट्रेट ने साथ आई दोनों सामाजिक महिला कार्यकर्ताओं का अदालत के काम में हस्तक्षेप बता दिया और बलात्कार पीडित सहित तीनों को जेल भेज दिया। कानून के मुताबिक जब कोई बलात्कार पीड़ित मजिस्ट्रेट के समक्ष अपना बयान दर्ज कराए तो कोई और मौजूद नहीं रह सकता। तीनों के खिलाफ बाद में अदालती अवमानना का मामला दर्ज करा दिया गया। बाद में बलात्कार पीडित को जमानत दे दी गई पर उसकी मदद करने वाली दोनों महिलाएं जेल में ही रहीं।दोनों महिलाओं ने इस मामले में सुप्रीम कोर्ट से अपनी तत्काल रिहाई की फरियाद की। उनकी पैरवी वरिष्ठ वकील वृंदा ग्रोवर ने की ।

बुजुगों को समय पर मिले

जनसत्ता ब्यूरो नई दिल्ली, 4 अगस्त।

सुप्रीम कोर्ट ने मंगलवार को कहा कि बुजुर्ग लोगों को समय पर पेंशन दी जानी चाहिए और कोविड-19 महामारी के दौरान देशभर में वद्धाश्रमों में रहने वाले लोगों को पीपीई. सैनिटाइजर और मास्क प्रदान किए जाएं। शीर्ष अदालत ने कहा कि बुजुर्ग लोग परेशानियों का सामना कर रहे हैं और प्रशासन को इस बात के लिए कदम उठाने चाहिए कि जहां उन्हें जरूरत हो, मदद पहुंचाई जाए।

न्यायालय ने कहा कि अधिकारियों को उन्हें समय पर पेंशन का भुगतान सुनिश्चित करना चाहिए और वृद्धाश्रमों में रहने वालों को पीपीई किट दी जानी चाहिए। न्यायमूर्ति अशोक भूषण की अध्यक्षता

वाले पीठ ने पूर्व केंद्रीय मंत्री और वरिष्ठ अधिवक्ता अश्विनी कुमार की याचिका पर सुनवाई करते हुए कहा कि बुजुर्गों को समय से पेंशन का भुगतान किया जाना चाहिए। इससे पहले, कुमार ने कहा कि महामारी के दौरान बुजुर्गों को समय पर पेंशन मिलना जरूरी है।

उन्होंने शीर्ष अदालत से कहा कि करोड़ों बुजुर्ग अकेले रह रहे हैं और इस बात के लिए उचित निर्देश जारी किए जाने चाहिए कि पात्र लोगों को समय पर पेंशन मिले। केंद्र की तरफ से वरिष्ठ अधिवक्ता वी मोहन ने पीठ से कहा कि राज्य सरकारें इस दिशा में प्रयास कर रही हैं। मोहन ने याचिका पर जवाब दाखिल करने के लिए जब एक सप्ताह का समय मांगा तो कुमार ने विरोध करते हुए कहा कि इस मामले में तत्काल कार्रवाई की जरूरत है।

प्रशांत भूषण व तरुण तेजपाल संबंधी

11 साल पुराने अवमानना मामले की सुनवाई पूरी

जनसत्ता ब्यूरो नई दिल्ली, 4 अगस्त।

सुप्रीम कोर्ट ने वकील प्रशांत भूषण के खिलाफ विचाराधीन 2009 के अदालती अवमानना के एक मामले में सुनवाई मंगलवार को पूरी कर ली। न्यायमूर्ति अरुण मिश्रा की अध्यक्षता वाले तीन जजों के एक खंडपीठ ने यह सुनवाई बंद अदालत में की। बचाव पक्ष के तीन वकीलों राजीव धवन, कपिल सिब्बल और हरीश साल्वे की दलीलों को खंडपीठ ने वाटेसएप वीडियो कॉल के माध्यम से सुना।

प्रशांत भूषण के पक्ष में राजीव धवन ने और तहलका के पूर्व संपादक तरुण तेजपाल के पक्ष में कपिल सिब्बल ने पैरवी की। अवमानना की कार्यवाही वरिष्ठ वकील हरीश साल्वे की शिकायत पर शुरू हुई थी। प्रशांत भूषण ने तहलका पत्रिका को दिए इंटरव्यू में आरोप लगाया था कि सुप्रीम कोर्ट के सोलह पूर्व मुख्य न्यायाधीशों में से आधे भ्रष्ट थे। सुनवाई के दौरान जजों ने कहा कि अवमानना और अभिव्यक्ति की स्वतंत्रता की बीच बहुत महीन विभाजन रेखा है। जर्जों ने धवन से कहा कि उनका मकसद

अभिव्यक्ति की स्वतंत्रता के अधिकार और एक संस्था के नाते न्याय पालिका की गरिमा की रक्षा की आवश्यकता की बीच संतुलन स्थापित करना है। पिछली सुनवाई के वक्त अदालत ने कहा था कि वह इस मामले के वकीलों को तैयारी के लिए वक्त दे रही है और अंतिम सुनवाई चार अगस्त को की जाएगी।

सुप्रीम कोर्ट ने तहलका में छपी सामाग्री के जरिए कुछ पूर्व मुख्य न्यायधीशों और कुछ सेवारत जजों पर आरोप लगाने के लिए नवंबर 2009 में प्रशांत भूषण और तरुण तेजपाल को अवमानना नोटिस जारी किए थे। इसी खंडपीठ ने पिछली 22 जुलाई को प्रशांत भूषण को ही उनके दो विवादास्पद टिवटस के लिए भी अवमानना के नोटिस जारी किए थे।

दिल्ली में जल्द धुंध टावर लगाने का निर्देश

जनसत्ता ब्यूरो नई दिल्ली, 4 अगस्त।

सुप्रीम कोर्ट ने मंगलवार को केंद्र से कहा कि वायु प्रदुषण पर अंकुश लगाने के लिए पूर्वी दिल्ली के आनंद विहार में धुंध टावर लगाने का काम जल्द से जल्द शुरू किया जाए। न्यायमूर्ति अरुण मिश्रा की अध्यक्षता वाले पीठ को केंद्र की ओर से सॉलिसीटर जनरल तुषार मेहता ने सूचित किया कि वायु प्रदूषण कम करने के लिए विशाल आकार के एअर प्यूरीफायर का ढांचा तैयार करने और धुंध टावर

लगाने में दस महीने का वक्त लगेगा और प्राधिकारी

यह समय-सीमा कम करने की स्थिति में नहीं हैं।

पीठ ने कहा, 'ठीक है लेकिन यह काम जल्द से जल्द शुरू होना चाहिए।' शीर्ष अदालत ने मेहता से कहा कि वह इस परियोजना की समय-सीमा के बारे में 10 अगस्त को न्यायालय को जानकारी दें और यह भी बताएं कि धुंध टावर लगाने का काम कब तक शुरू हो सकता है। इस मामले की वीडियो कॉन्फ्रेंस के माध्यम से सुनवाई के दौरान मेहता ने कहा कि यह काम आइआइटी, मुंबई की देखरेख में किया जाएगा जबिक इसके लिए धन सरकार मृहैया कराएगी।

इससे पहले, केंद्र ने 30 जुलाई को न्यायालय को सूचित किया कि पूर्वी दिल्ली के आनंद विहार में धुंध टावर लगाने के लिए सहमति पत्र तैयार हो गया है और इस पर सभी हितधारक हस्ताक्षर करेंगे।

कोरोना विषाणु में नहीं के बराबर परिवर्तनशीलता : आइसीएमआर

जनसत्ता ब्यूरो नई दिल्ली, 4 अगस्त।

भारतीय आयुर्विज्ञान अनुसंधान परिषद (आइसीएमआर) का कहना है कि कोरोना विषाणु के स्ट्रेन में बहुत मामूली या नहीं के बराबर परिवर्तनशीलता आई है। आइसीएमआर के महानिदेशक डॉक्टर बलराम भार्गव ने मंगलवार को आयोजित हुए एक संवाददाता सम्मेलन में कहा कि महामारी की शुरुआत से राष्ट्रीय विषाणु विज्ञान संस्थान (एनआइवी), पुणे स्ट्रेन पर अध्ययन कर रहा है। एनआइवी ने वुहान, इटली और ईरान से लौटे संक्रमित यात्री से प्राप्त विषाणु में पाया कि विषाणु 99.996 फीसद एक जैसा है। उन्होंने कहा कि हां, स्ट्रेन में परिवर्तन तो हुआ है लेकिन यह नहीं के बराबर है। उन्होंने कहा कि किसी विषाणु के स्ट्रेन में पूरी तरह परिवर्तन में 10 से 15 साल का समय लगता है।

डॉक्टर भार्गव की बात को एक अध्ययन भी सही साबित करता है। एक नए अध्ययन के अनुसार इस बीमारी को फैलाने वाले सार्स-सीओवी-2 विषाण के कम से कम छह प्रकार (स्ट्रेन) होने के बाद भी यह बहुत कम परिवर्तनशीलता प्रर्दिशत करता है। पत्रिका 'फ्रंटियर्स इन माइक्रोबायलॉजी' में प्रकाशित और सार्स-सीओवी-2 पर अब तक के सबसे गहन अध्ययन में कोरोना विषाणु के 48,635 जीनोम का विश्लेषण किया गया है। इन जीनोम को दुनियाभर में अनुसंधानकर्ताओं ने प्रयोगशालाओं से प्राप्त किया।

इटली के बोलोना विश्वविद्यालय के अनुसंधानकर्ताओं ने विषाणु के सभी महाद्वीपों में फैलने के दौरान इसके फैलाव और उत्परिवर्तन की मैपिंग की। अध्ययन के निष्कर्ष में सामने आया कि नोवेल कोरोना विषाणु बहुत कम परिवर्तनशीलता (वैरिएबिलबटी), प्रति नमूने करीब सात उत्परिवर्तन प्रर्दिशत करता है। अनुसंधानकर्ताओं के अनुसार सामान्य इन्फ्लुएंजा में परिवर्तनशीलता की दर दोगुने से अधिक होती है। बोलोना विश्वविद्यालय के अनुसंधानकर्ता फेडेरिको गियोर्जी ने कहा कि सार्स-सीओवी-2 कोरोना विषाण संभवतः पहले ही मानव जाति को प्रभावित करने के स्तर पर पहुंच चुका है और यह उसके विकास क्रम में बहुत कम बदलाव को इंगित करता है। उन्होंने कहा कि इसका आशय हुआ कि हम इसके खिलाफ कोई टीका समेत अन्य जो भी उपचार तरीके विकसित कर रहे हैं, वे सभी तरह के विषाणु के खिलाफ प्रभावी हो सकते हैं।

अनुसंधानकर्ताओं ने कहा कि इस समय नोवेल कोरोना विषाण के छह प्रकार सामने आए हैं। उन्होंने कहा कि इनमें सबसे मौलिक 'एल' स्ट्रेन है जो दिसंबर 2019 में वुहान में सामने आया था। इसके पहले उत्परिवर्तन के बाद 'एस' स्ट्रेन सामने आया जिसका पता 2020 की शुरुआत में चला, वहीं जनवरी के मध्य में 'वी' और 'जी' स्ट्रेन सामने आए। अनुसंधानकर्ताओं के अनुसार आज की तारीख में सबसे ज्यादा प्रकोप स्ट्रेन 'जी' का है जो फरवरी के अंत तक 'जीआर' और 'जीएस' स्ट्रेन में उत्परिवर्तित हुआ।
