**Sub: Intimation under Regulation 30 of SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015 read with SEBI Circular no. SEBI/HO/CFD/CMD1/CIR/P/2020/84 dated 20<sup>th</sup> May 2020- Material Impact of Covid-19 pandemic on Operations of the Company.**

Dear Sirs,

This is further to our letter dated 8<sup>th</sup> June, 2020 on the above subject, we wish to inform you of the following details pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read together with the SEBI circular No. SEBI/HO/CFD/CMD1/CIR/P/2020/84 dated 20<sup>th</sup> May 2020 on the intimation of impact of COVID 19 Pandemic on listed Companies:

1. Consequent to outbreak of COVID - 19 which has been declared a pandemic by the World Health Organization (WHO), Government of India and State Governments have declared lockdown which have impacted business in general, earnings prospects causing erosion in value of Companies. The resultant impacts on the fair valuation of investment have been reflected in Profit or Loss and the Other Comprehensive Income statement of the Company. In case of one of the subsidiary involved in manufacturing of machinery for the Rubber and Tyre industries, the operations were affected due to loss of more than a month's production because of the suspension of the operations, disruptions in supply chain and non-availability of personnel during lock down. Though the production has started in the first week of May 2020, due to absenteeism, consequent to nationwide lockdown, the normal production is still affected. The Stock Exchanges were permitted to function uninterrupted during the lockdown and as such investment and related operations of the Company were not affected substantially.
2. Based on current indicators of future economic conditions, the Company expects to recover the carrying amount of financial and non financial assets held by the Company. The Company will continue to monitor any material changes to the future economic conditions and the same will be considered on crystallization.
