Editorial....

મ્યાંમાર સરહદે વાડાબંધી યોગ્ય

રોબર્ટ ક્રોસ્ટ નામના એક ચિંતકે યોગ્ય જ કહ્યું તું, 'ગુડ કૅન્સિસ મેક ગુડ નેબર' જે કહે છે કે બહેતર વાડાબંધીથી બહેતર પડોશી બનાવી શકાય છે. આ વાત ભારત અને મ્યાંમાર સીમા વિશે પણ સચોટ બેસે છે. એને જ ધ્યાનમાં રાખીને કેન્દ્ર સરકારે ભારત અને મ્યાંમાર વચ્ચે મુક્ત આવાગમન વ્યવસ્થા ખતમ કરવાનો નિર્ણય લીધો છે. એવો નિર્ણય લેવા પાછળ કેટલાક વર્ષોથી વિચારણા ચાલતી હતી, પરંતુ કેન્દ્ર સરકાર એવું કોઈ પગલું ઉઠાવેલું ભરવા નહોતી માગતી જેનાથી ભારત-મ્યાંમાર સંબંધો જે પહેલાંથી જ સંવેદનશીલ રહ્યા છે, તેના પર કોઈ નકારાત્મક અસર પડે. પરંતુ જ્યારે કેન્દ્ર સરકારે જાણી લીધું કે મ્યાંમારથી ગેરકાયદે પૂર્વાત્તર ભારતમાં આવનારા શરણાર્થી પૂર્વાત્તરની શાંતિ સુરક્ષા માટે ખતરો બનતા જાય છે, ત્યારે સરકારે આ કઠોર નિર્ણય લીધો છે.

વસ્તુતઃ ભારત મ્યાંમારની ૧૬૪૩ કિમી લાંબી આંતરરાષ્ટ્રી સીમામાંથી મોટાભાગની સીમા પર વાડા નથી અને મણિપુર, જે મ્યાંમાર સાથે લગભગ ૩૮૦ કિમી લાંબી સીમાથી જોડાયેલું છે તેની તો માત્ર ૧૦ કિમી સીમા પર ફેન્સિંગ થઈ છે. જોકે મ્યાંમાર વિશ્વનું સૌથી મોટું અફીણ ઉત્પાદક દેશ બની ગયું છે, જેથી ભારતમાં ગેરકાયદે ડ્રગ્સની તસ્કરી એક મોટી સમસ્યા બની ગઈ છે. જ્યારે રોહિંગ્યા, કુકી, ચિન જેવા અંધનિક સમુદાયો ગેરકાયદે ઉત્તર-પૂર્વમાં ઘૂસી રહ્યા છે, જેનાથી ત્યાંની જનસંખ્યામાં બદલાવ આવી રહ્યો છે. તેથી જરૂરી હતું કે જે હેતુથી ભારત મ્યાંમાર વચ્ચે ફ્રી મુવમેન્ટ રેજીમની વ્યવસ્થા કરવામાં આવી હતી તેનો ઉદ્દેશ્ય પૂરો ન કરીને ભારતની આંતરિક સુરક્ષા માટે પડકાર બને છે, તો તેને ખતમ કરવામાં આવે.

ભારત સરકારે બંને દેશોની સ્થાનિક જનજાતિઓની મુક્ત આવાગમનની વ્યવસ્થા કરી હતી, જેથી વ્યક્તિથી વ્યક્તિ વચ્ચે સંપર્ક વધે, સાંસ્કૃતિક વિનિમયને મજબૂતી મળે, જેનાથી પરસ્પર વિશ્વાસ બંને દેશોમાં વધે. ભારત સરકારે ફ્રી મુવમેન્ટ રેજીમની વ્યવસ્થા એટલે નહોતી કરી કે મ્યાંમારના અરાજક તત્ત્વ પૂર્વાત્તર ભારતમાં અલગતાવાદી આંદોલનનું પડચંત્ર રચવા આવી જાય, પૂર્વાત્તરના લોકોને ભારત સરકાર વિરુદ્ધ વિદ્રોહી ગતિવિધિઓ કરવા ઉત્કેરે, પૂર્વાત્તરને હથિયાર, ડ્રગ્સ, ગોલ્ડ વગેરે ચીજોની ગેરકાયદે તસ્કરી કરવાનો રસ્તો સમજવા લાગે. ભારત સરકારે તો આંતરરાષ્ટ્રીય સીમા પર હાટ ખોલીને સ્થાનિક લોકોની આજીવિકાના સંરક્ષણનું માનવીય કાર્ય કર્યું છે. કહેવાનો મતલબ છે કે વૈશ્વિકરણના દોરમાં મુક્ત આવાગમન પર વિના કારણે રોક લગાવવાની માનસિકતા ભારત જેવો ઉદારવાદી દેશ તો ક્યારેય નથી રાખતો, પરંતુ પોતાની રાષ્ટ્રીય આંતરિક સુરક્ષા માટે તેણે આ કઠોર સંસલા કરવા પડે છે.

અમેરિકી ડ્રગ એન્ફોર્સમેન્ટ અનુસાર, મ્યાંમાર દિક્ષણ પૂર્વી એશિયાનું ૮૦ ટકા હેરોઈન ઉત્પાદન કરે છે અને વૈશ્વિક પૂર્વઠાના ૬૦ ટકા માટે જવાબદાર છે. કોકેઈનની તસ્કરી માટે પણ એ જવાબદાર છે. ચીન અને મ્યાંમારના ડ્રગલોર્ડ્સને એકબીજાના સહયોગ સમર્થન સમય સમય પર મળતું રહે છે, પરંતુ સર્વાધિક ચિંતાની વાત એ છે કે ભારત મ્યાંમારની સીમા પર કેટલીય હેરોઈન લેબ્સ સક્રિય છે. મિઝોરમમાં મ્યાંમારના રસ્તેથી એન્ફોર્સમેન્ટ, યાખા ટેબલેટ્સ, કેપ્ટી ડ્રગ્સ, પાર્ટી ડ્રગ્સની તસ્કરી અને ગેરકાયદે ખરીદ-વેચાણ પણ ઘણું વધી ગયું છે, જે ઉત્તર-પૂર્વી ભારતના યુવા માનવ સંસાધનને નુકસાન પહોંચાડી રહ્યાં છે.

ભારત મ્યાંમાર વચ્ચે ફ્રી મુવમેન્ટ વ્યવસ્થા ૨૦૧૮ માં લાવવામાં આવી હતી. મિઝોરમ, મણિપુર, નાગાલેન્ડ અને અરુણાચલ પ્રદેશથી પસાર થતી ૧૬૪૩ કિમી લાંબી ભારત-મ્યાંમાર સીમા પર એન્ફોર્સમેન્ટની વ્યવસ્થા રહી. આ પ્રણાલીના લાભ વિશે પણ ભારત સરકારે વિચાર્યું હતું કે આનાથી બંને દેશોના કૂટનીતિક અને સૈન્ય સંબંધોમાં મજબૂતી આવી હતી. મુક્ત આવાગમન વ્યવસ્થા બંને દેશો વચ્ચે એક સમજૂતી છે જે બંને તરફ સીમા પર રહેનારી જનજાતિઓને બીજા દેશની અંદર ૧૬ કિમી સુધી કોઈ વિઝા વગર મુસાફરી કરવાની અનુમતી આપે છે. આ બંને પક્ષોના સમુદાયોને સક્ષમ અધિકારીઓ દ્વારા જારી સીમા પાસ (એક વર્ષની વેલિડિટી) દેખાડતાં, કાયદેસર પરમિટ સાથે ૭૨ કલાક રહેવાની અનુમતિ આપે છે. આંતરકલાકો અને કેટલાય અપરાધી આ વ્યવસ્થાનો દુરુપયોગ કરવા લાગ્યા, ત્યારથી મોટી સરકાર વિવશ છે કે આના વિશે કોઈ ઠોસ નિર્ણય લેવામાં આવે. મુક્ત આવાગમન વ્યવસ્થાનો ખોટો ઉપયોગ મ્યાંમાર તરફથી હથિયારો, નશીલા પદાર્થો, તસ્કરીના સામાનો અને નકલી ભારતીય ચલણી નોટોની તસ્કરી રૂપે કરવાના કેટલાય પુરાવા અસમ રાઈફલ્સ પહેલાં પણ આપી ચૂકી છે. જ્યારથી મ્યાંમારમાં કુકી-ચિન સમુદાય પર સરકારની કાર્યવાહી થઈ રહી છે, ત્યારથી મુક્ત આવાગમન વ્યવસ્થાનો ઉપયોગ ગેરકાયદે પ્રવાસ માટે કરવામાં આવી રહ્યો છે.
