Subject: Jawaharlal Nehru Port Awards 250 CR yearly maintenance dredging contract to DCIL.

Visakhapatnam, Wednesday, 15th June 2022: Dredging Corporation of India Limited (DCI), Visakhapatnam is a listed dredging company in India under the consortium of four (4) major ports Authorities viz a viz, Visakhapatnam Port, Paradip Port, Jawaharlal Nehru Port and Deendayal Port holding majority shares of 73.47%. DCI is the premier dredging organization of India catering to the dredging and allied services to Major Ports, Minor Ports, Indian Navy, Fishing Harbours and other maritime organizations by deepening and maintaining the safe navigational channel for EXIM activities.

JNPA awarded the maintenance of Mumbai & JNPA navigational channel to DCIL that includes dredging of 20 Million Cubic Meter Plus or minus 20% yearly with the Project cost of about 250 CR INR per year.

Ministry of Ports Shipping & Waterways promulgate dredging guidelines 2021 and emphasized that major ports to award dredging contract on long term basis. Long term of three years contract awarded by JNPA shall be an assured revenue to DCI top line amounting to 250 CR INR/ yearly.

The extension of the contract by JNPT is feather on the cap of DCI which is aiming at a record highest ever turnover of Rs.1000 Cr for this financial year 2022-23.
