Subject: Status Update on acquisition - Intimation under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015.

Dear Sir / Madam,

This is in reference to the disclosure made by Samvardhana Mother's International Limited (“**SAMIL**” / the “**Company**”) vide letter dated July 4, 2023, October 4, 2023 and November 21, 2023, thereby informing acquisition of 81% stake in Yachiyo 4W business (“**Y4W**”) housed under Yachiyo Industry Co., Ltd. (“**Yachiyo**” or “**Target**”) by **SAMIL** via 100% subsidiary of SMRP B.V. from Honda Motor Co. Ltd (“**Honda Motor**”) and acquisition of 100% paid-up equity capital of Yachiyo India Manufacturing Private Ltd (“**YIM**”), a 100% subsidiary of the Target.

Post completion of the tender offer, as indicated in our disclosure dated November 21, 2023, Honda Motor had acquired remaining stake in Yachiyo by squeeze out process as defined by Japanese regulations on January 12, 2024 thereby making Yachiyo its wholly owned subsidiary.

Further, MSSL Mideast (FZE) which is a 100% subsidiary of SAMIL will acquire 100% of Yachiyo's Indian subsidiary i.e., Yachiyo India Manufacturing Private Limited (“**YIM**”).

Subject to completion of other ongoing conditions precedents for the transaction, the closing is now expected to be completed within March 2024.

The disclosure is pursuant to Regulation 30(7) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.
