TOKYO PARALYMPICS

Winning gold a moment to cherish: Pramod Bhagat

Bhagat attributed his win against Great Britain's Daniel Bethell in the finals to a strategy that he devised after losing to the same opponent in the past

IT WAS A "moment to cherish" for Pramod Bhagat who on Saturday clinched India's first badminton gold in Paralympics and he attributed his win against Great Britain's Daniel Bethell in the finals to a strategy that he devised after losing to the same opponent in the past.

Reigning world champion Bhagat beat Bethell 21-14 21-17 in the summit clash. Another Indian, Manoj Sarkar won the bronze after beating Daisuke Fujihara in the third place play-off.

its debut at the Paralympics this year, Bhagat, the current world No. 1, thus became the first Indian to win a gold medal in the sport.

"This is a very proud moment for me. I'm representing the Indian badminton community and India as a whole," Bhagat said after winning the gold.

"This is the first time that para badminton is appearing in the Paralympics and winning the first gold medal for India is a moment to cherish for me," said 33-year-old from Odisha.

Bhagat, who had contracted polio when he was 4 With badminton making years old, thus avenged his loss to Bethell at the Japan Para Badminton International in November 2019. "I played the same opponent in Japan two years ago and I lost. That was a learning opportunity for me.

> "Today it was the same stadium and the same environment, and I devised a strategy to win. I was very determined."

On his strategy, Bhagat said, "I just focused on playing the shuttle on each and every point rather than on winning the whole game. Every point was precious."

Bhagat also remains in contention for a bronze

medal in mixed doubles SL3-SU5 class. He and his partner Palak Kohli will square off against Japanese pair of Daisuke Fujihara and Akiko Sugino in the bronze medal play off on Sunday.

They had lost the semifinals 3-21 15-21 to Indonesian combination of Hary Susanto and Leani Ratri Oktila earlier in the day. Bhagat picked up the sports after

watching his neighbours play. Initially, he competed against able-bodied players before getting into competitive para badminton in 2006. He eventually emerged as one of the best para shuttlers in the country with 45 international medals under his belt, including four world championship gold medals and a gold and a bronze in 2018 Asian Para Games.

He also had started his career as a badminton coach but took a break in 2019 to fo-Tokyo Paralympics qualification.

In 2019, he received the Arjuna Award and Biju Patnaik Award for Excellence in Sports in India.

History beckons IAS officer Suhas Yathiraj

HISTORY BECKONS INDIAN Administrative Service (IAS) officer Suhas Lalinakere Yathiraj when he steps into the court for the badminton finals at the Paralympics in Tokyo on Sunday with a shot at the gold medal. Even if he loses and wins a silver, the 38-year-old district

magistrate of Gautam Buddh Nagar (Noida) will have scripted history as the first-ever officer to win a medal at the Paralympics.

Yathiraj, currently world No. 3 in SL4 category, has played three matches, including the semifinals on Saturday, in the ongoing Games.

He has been at his dominating best against his rivals. While it took him less than 20 minutes to sail through the first two matches, Yathiraj outwitted Indonesia's Fredy Setiawan 21-9 21-15 in 31 minutes in the first semifinal. The 2007-batch IAS officer, with leg impairment, will face top seed Lucas Mazur of France in the final on Sunday.

"History under making! Suhas LY, IAS, DM GB Nagar (Noida), UP, India in Men's singles para-badminton SL4 finals. He beats Indonesia's S Freddy 2-O in semifinals. Now will be playing for Gold on September 5," the IAS Association, a group of serving and retired administrative officers, tweeted.

With the Karnataka-born engineer graduate making it to the final at the showpiece, internet users have been rallying support for him by trending the hashtag #Cheer4Suhas on social media platforms.

Several of the residents' Whatsapp groups in Noida are also filled with congratulatory messages on their DM's sporting feat. Yathiraj, who graduated as computer engineer from NIT Karnataka with a distinction, has previously served as the district magistrate of Prayagraj, Agra, Azamgarh,

For the last one and a half years, he had been at the forefront of the pandemic management in Gautam Buddh Nagar since his appointment in the western UP district on March 30, 2020. Prior to his departure to Tokyo in the last week of August, Yathiraj, when asked about his badminton practice and work as DM, had told reporters, "I practice from 10pm for two hours after all the day's works are over. I have been managing my game and administrative duties this way for around six years now."

Yathiraj said his professional journey started in 2016 while he was the DM of Azamgarh district in eastern UP and a badminton championship was organised there. "I was a guest at the inauguration of the tournament and expressed desire to participate. Until then it was a CREDIT: TWITTER

I got a chance to play there and defeated state-level players," he had said. It was there, he said, the Gaurav Khanna, the current coach of the country's para-badminton team, spotted him and push-started his professional journey.

In 2016 itself, he participated in the Asian Championship in Beijing and become the first non-ranked player to win the gold medal. More international recognition was awaiting him as he went on to win medals at BWF Turkish championship in 2017 and 2019 besides the latest, a gold, in Brazil in 2020, just before the pandemic started ravaging India and world. When his participation in the Tokyo Paralympics was confirmed in July, Yathiraj said the event was no doubt going to be a challenge and being the world number three in his category, he was hopeful for a medal. "Over the years, we have seen that small margins make the difference between winners and losers. I have lost games with a margin of millimeters and won by centimeters. When I compete in Tokyo, I know every player will be there hoping to win a medal," Yathiraj told reporters.

Dream to see Indian flag flying high fulfilled: Singhraj Adana

SHOOTER SINGHRAJ ADANA, who wrapped up his debut Paralympics campaign with two medals, on Saturday said his dream of seeing the Indian flag flying the highest in his event has been fulfilled. While Adana took the silver, the gold went to 19-year-old Manish Narwal as the two shooters made it a sensational one-two finish for the country in the event. The 39year-old Adana, who had won a bronze in the men's 10m air pistol SH1, added a mixed 50m pistol SH1 silver to his haul, making him only the second athlete in the ongoing Paralympics who has won two medals, Avani Lekhara being the other."I was delighted when I saw our flag being raised with the national anthem. I will always remember the Tokyo Paralympics with my bronze and silver," Adana said after his silver-winning performance."I always dreamt about seeing the Indian flag flying the highest, that dream has been fulfilled today. I will also remember also everyone's blessings and love. A huge thanks to my coaches and staff," added Adana who competes with polio-impaired lower limbs. Narwal, who holds the world record in the category, smashed the Paralympic record to claim the yellow metal in his debut Games.

India records 42,618 virus cases, 330 deaths in a day

INDIA'S COVID-19 INFECTION tally rose by 42,618 in a day to reach 3,29,45,907 while the number of active cases touched 4,05,681 following an increase for the fourth consecutive day, according to the Union Health Ministry data updated on Saturday. The death toll climbed to 4,40,225 with 330 more people succumbing to the viral disease, showed the data updated at 8 am. In a span of 24 hours, the active caseload rose by 5,903. The number of active cases now comprises 1.23% of the total infections, while the national Covid-19 recovery rate was recorded at 97.43 %, the ministry said. The daily positivity rate was recorded at 2.50% and the weekly positivity rate was 2.63%. It has been below three per cent for the last 71 days. As many as 17,04,970 tests were conducted on Friday taking the total cumulative tests conducted so far for detection of Covid-19 in the country to 52,82,40,038. Under the nationwide vaccination drive, a total of 67.72 crore vaccine doses have been administered so far. Of the 330 fatalities recorded in a day 131 are from Kerala and 92 from Maharashtra. Of the to-

tal deaths in the country, 1.37.643 are from Maharashtra, 37,380 from Karnataka, 34,980 from Tamil Nadu, 25,082 from Delhi, 22,854 from Uttar Pradesh, 21,280 from Kerala and 18,483 from West Bengal. The Union health ministry stressed that more than 70% of the deaths occurred due to comorbidities. "Our figures are being reconciled with the Indian Council of Medical Research," the ministry said on its website.

FSSAI asks e-tailers to delist non-dairy products claiming as dairy items

FOOD SAFETY REGULATOR FS-SAI on Saturday directed e-commerce companies to delist immediately the non-dairy and plant-based beverages that have label claiming as 'dairy' products. The Food Safety and Standards Authority of India (FSSAI), in a statement, said it has also directed states to investigate use of dairy terms on the labels of plant-based beverages and food products. "Since a lot of such products are sold through ecommerce Food Business Operators (FBOs), FSSAI has instructed all e-commerce platforms to delist such products, which are reported to be in contravention to the regulatory provisions related to the application of dairy 'terms' from their online platforms, immediately," it said.
