Flower Power

ONE morning in 2015, Ankit Agarwal and his friend sat on the ghats of River Ganga in his hometown of Kanpur. Both watched gloomily as devotees took a dip in the river and drank its water although it was visibly filthy. Agarwal saw temples and worshippers adding to the muck by throwing flowers and he was struck by an idea that could help reduce the pollution of the sacred river. That was how HelpUsGreen (HUG) was born.

Along with his childhood friend Karan Rastogi, Agarwal developed the idea of recycling floral waste. After months of research, the duo devised a way by which the flowers could be made into incense and organic vermicompost. They called their process "flowercycle", a pioneering and profitable solution to the floral waste problem.

Women workers collect flowers from temples and mosques, which are then sorted, cleaned and sprayed with biological culture. The flowers are washed and the water is used later for making the fertilizer. The petals are dried, powdered and mixed into a dough which is rolled into incense sticks and cones. The vermicompost is prepared from the green parts of the flowers and leaves.

Taking flowercycling a step further, HUG has developed Florafom, dubbed the world's first-ever biodegradable thermocool made from flowers. It was developed in collaboration with IIT engineers. They are also working on biodegradable leather. HUG also produces do-it-yourself incense-making kits that come with instructions and materials.

In 2018, Agarwal made it to the Forbes 30 under 30 list and HUG won a UN Climate Action Award. HUG plans to expand its activities to more cities along the Ganga, including in Bangladesh and Nepal.
