REVIEW THE REQUESTS RECEIVED FROM MR. VISHWAJIT B DAHANUKAR AND ms. GOPIKA DILIP DAHANUKAR FOR RECLASSIFICATION FROM PROMOTERS TO PUBLIC SHAREHOLDERS

The Board was informed that Mr. Vishwajit B Dahanukar and Ms. Gopika Dilip Dahanukar, persons belonging to the 'promoter and promoter group' of the Company, had each vide their respective letters dated 20th April, 2023 requested the Company for re-classification from the 'promoter and promoter group' category to 'public' category shareholder of the Company. The Company intimated the aforesaid request(s) for re-classification to BSE Limited on 22nd April 2023 and 21st April 2023.

The letters received from Mr. Vishwajit B Dahanukar and Ms. Gopika Dilip Dahanukar were placed before the Board for its perusal.

The Board was informed that Mr. Vishwajit B Dahanukar and Ms. Gopika Dilip Dahanukar holds No equity shares of the Company.

It was also informed that Mr. Vishwajit B Dahanukar and Ms. Gopika Dilip Dahanukar request letters informed the Company that they are neither a part of the Board nor do they hold any key managerial position in the Company.

Further, they had confirmed in their letters that they do not participate in the management of the Company in any manner or capacity and do not have any special rights in the Company through formal or informal arrangements, including any shareholder agreement.

The Board was also apprised that each of them are satisfying all the conditions specified in Regulation 31A of the Listing Regulations. The Board was further informed that in terms of Regulation 31A of the Listing Regulations, the said re-classification shall require the approval of the Board, shareholders/ members of the Company and the stock exchanges where the shares of the Company are listed namely, BSE Limited ("Stock Exchanges").

Accordingly, on the basis of the rationale provided above and in accordance with the provisions of Regulation 31A of the Listing Regulations, the Board was of the view that the respective requests

The Board considered the matter and passed the following resolution unanimously:
