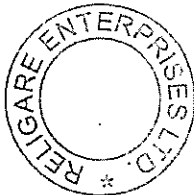

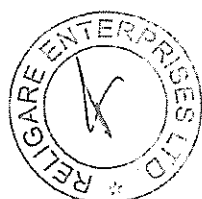

(EFA) (COMM) NO.-6 OF 2016) praying for amongst other reliefs for the stay of redemption of said NCRPS pending the outcome of investigations into the affairs of the Company and its subsidiaries initiated by the SEBI and SFIO. The matter is currently sub judice.
