Consequent to aforesaid allotment, the issued, subscribed and paid-up equity share capital of the Company stand increased from INR 12,20,96,758 (consisting of 12,20,96,758 equity shares of face value of INR 1 each) to INR 12,24,82,493 (consisting of 12,24,82,493 equity shares of face value of INR 1 each).
