This is to inform you that as per Shareholding pattern received from our Registrar & Share Transfer Agent (RTA) for the last quarter ended on 31-03-2022, we came to know that one of the Promoter Group Company namely 'Bihar State Industrial Development Corporation Limited' (BSIDC) has sold 2,44,217 (0.27%) equity shares of the Company during the quarter January – March 2022, without any intimation to the Company. Now its residual shareholding is 65,15,743 (7.22%) equity shares as on 31-03-2022.

This is violation of Regulation 7(2)(a) of the SEBI (Prohibition of Insider Trading) Regulations, 2015 and Company's Insider Code of Practice as approved by the Board of Directors as per SEBI/Listing norms. In this regard, a notice is being sent to the above Company for providing its reply.


