Death of three youths in Dahod: Police suspect fatal accident

THE DAHOD district police have begun a probe into the death of three youths from Kapdi village of Devgarh Baria taluka of the district, whose bodies were recovered from Dangariya village on Friday. The police said that prima facie investigation and autopsy reports suggest a fatal accident in which the motorcycle on which the three youths were travelling fell into a gorge near the village.

The bodies of Yusuf Ayub Kamaal, 21, Akbar Sattar Patel, 25, and Sameer Jathera, 21, were recovered from a gorge near Dangariya village on Friday, along with the motorcycle that they were riding. On Saturday, the district police, which is probing allegations
