- 1) The statement pursuant to Section 102 of the Companies Act, 2013 (the Act) setting out material facts is attached herewith.
- 2) The Notice of postal ballot is being sent to all the members, whose names appear on the register of members / list of beneficial owners as received from National Securities Depository Limited (NSDL) / Central Depository Services (India) Limited (CDSL) as on 16th April 2021 (Cut-off date).
- 3) Notice of postal ballot along with postal ballot form containing the process, instructions and the manner of conducting e-voting is being sent under the permitted mode to all the members whose names are available in the Company's register of members as on the cut-off date. Further in the case of members who had already provided their e-mail IDs to the Company / Share Transfer Agent will also be receiving the Postal Ballot form and the relevant enclosures through electronic mode.
- 4) Voting rights shall be reckoned on the paid up value of equity shares registered in the name of the member as on 16th April 2021. Members can opt for their entire voting rights as per their discretion.
- 5) In compliance with the provisions of Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (read together with their subsequent amendments), as well as Sections 108 and 110 of the Act read with the Companies (Management and Administration) Rules, 2014, (as amended) the Company is offering e-voting facility to all of its members. For this purpose, the Company has entered into an agreement with NSDL for providing e-voting facility to enable the members to cast their votes electronically instead of dispatching the postal ballot form. Kindly note that the members can opt for only one mode of voting, i.e. either by physical postal ballot or through e-voting. To accord approval for the re-appointment of Mr.A.Krishnamoorthy as Managing Director for a period of 2 years effective 1st April 2021 and payment of remuneration to him:

At the Board Meeting held on 26th March 2021, Mr.A.Krishnamoorthy was re-appointed as Managing Director for a further period of 2 (Two) years from 1st April 2021 pursuant to Sections 196, 197 and 203 and other applicable provisions of the Act read with Schedule V to the Act upon approval by the Nomination and Remuneration Committee at their meeting held on 26th March, 2021. The terms and conditions relating to the re-appointment of Mr.A.Krishnamoorthy as Managing Director are listed below.

Salary : Rs.5,00,000/- per month

Perquisites : Perquisites to be allowed in addition to salary and commission as listed below.

Commission : As a percentage within the overall ceiling of the net profits of the Company computed under Section 197 and other applicable provisions of the Act.

Perquisites:

- (a) Reimbursement of expenses on gas, electricity, water, security and furnishings.
- (b) Medical Reimbursement: Expenses incurred by the Managing Director and his family including any Insurance cover for health
- (c) Leave Travel Concession: For the Managing Director and his family in accordance with rules specified by the Company
- (d) Club Fees: Fees of Clubs subject to a maximum of two clubs. This will not include Admission and life membership fee
- (e) Personal Accident Insurance Premium for cover as per the Rules of the Company
- (f) Gratuity payable should not exceed half month's salary for each completed year of service.
- (g) Leave facility as applicable to other Senior Executives of the Company shall be allowed

The Managing Director shall be entitled to all actual expenses including reimbursement of travelling and entertainment expenses incurred in the course of the Company's business, which shall not be treated as an item of remuneration. He is not entitled to sitting fees. Apart from the remuneration aforesaid, the Managing Director shall be entitled for provision of car with driver, telephone, mobile and other communication facilities.

Minimum Remuneration:

In the event of loss or inadequacy of profits in any financial year during the tenure of the appointment, the Managing Director shall be paid remuneration by way of salary and perquisites as set out above, as minimum remuneration.

He is also Chairman & Managing Director of M/s.Simpson & Co. Ltd. The total remuneration receivable by him in both the companies will be in accordance with Section 197 read with Schedule V to the Act.

Termination: Either party namely the Company and the Managing Director, may terminate the Agreement by giving to the other party three months' notice in writing. The agreement which has been approved by the Board of Directors at their meeting held on 26th March 2021 detailing therein the terms and conditions detailed above along with the responsibilities and duties to be discharged by the Managing Director in that capacity has been entered into with the Managing Director.

Mr.A.Krishnamoorthy is not liable to retire by rotation.

The remuneration payable to Mr.A.Krishnamoorthy from 1st April 2021 has been recommended by the Nomination and Remuneration Committee taking into consideration his contribution to the company and approved at the Board Meeting held on 26th March 2021.

The terms of re-appointment of Mr.A.Krishnamoorthy as Managing Director of the Company and the related remuneration payable to him needs approval of the members by means of passing a special resolution at a General Meeting of the Company. Hence, the special resolution is proposed for consideration of the members.

Mr.A.Krishnamoorthy aged 83 years has been associated with the Company as Director from 26th June 1970 to 31st August 1975, as Managing Director from 1st September 1975 and as the Chairman & Managing Director from 13th July 1992 till 31st March 2015 and as Managing Director from 1st April 2015 and is being proposed to be re-appointed as Managing Director from 1st April 2021 for a further period of 2 years.

Mr.A.Krishnamoorthy, Managing Director, holding 50 equity shares of Rs.10/- each in the company, is a member of the Stake-holders Relationship cum Investors Grievance Committee in the Company. Back-ground details : Mr.A.Krishnamoorthy has been associated with the Company as Director from 26-06-1970 as Managing Director from 01-09-1975 and as Chairman & Managing Director from 13-07-1992 till 31st March 2015. Further he continues to be the Managing Director from 1st April 2015. During this period, he played a major role in expansion activities in the Company, including acquiring new technology for materials and process. He was instrumental in entering into a Joint Venture agreement for the manufacture of polymer bushes for the first time in India and enlarged intermediate products' capacity and capabilities.


