Apple supplier Salcomp sees India revenue of \$2-3 billion

REUTERS Chennai, February 13

FINLAND'S SALCOMP, A supplier to Apple, is planning to more than double its workforce in India to nearly 25,000 over the next three years, a company executive

said on Monday. "China Plus One strategy is at its peak at this moment... The whole supply chain is now kind of looking at an alternative. And India is poised to be one of the best alternatives," said Sasikumar Gendham, managing director, Salcomp Manufacturing India."It's time to diversify and decluster supply chain beyond China."

Salcomp, a major supplier

The Finnish company is planning to more than double its workforce in India to nearly 25,000 over the next three years

of chargers to the iPhone maker, is also setting up a housing complex with entertainment and education for about 15,000 people, said Gendham. Salcomp, which currently employs about 12,000 people in Chennai with 85% of them being women, had reached an agreement in 2019 to take over a facility, formerly owned by Finnish telecom equipment maker Nokia, in the southern Indian city of Chennai and started operations in 2020.

Foxconn, another Apple supplier, also plans to quadruple the workforce at its iPhone factory in India over two years, Reuters had reported last year.

Currently, iPhones are assembled in India by at least three of Apple's global suppliers: Foxconn and Pegatron in Tamil Nadu; and Wistron in nearby Karnataka state.

IP Morgan analysts estimated last year that Apple may make one of four iPhones in India by 2025, and 25% of all Apple products, including Mac, iPad, Apple Watch and AirPods, will be manufactured outside China by 2025 from 5% currently.

SHARE DISPUTE CASE

SC asks SpiceJet to pay ₹270 cr to Maran high in January

Also orders the airline to pay ₹75 cr as interest dues

FE BUREAU New Delhi, February 13

IN THE SHARE dispute case between SpiceJet CMD Ajay Singh and ex-promoter Kalanithi Maran, the Supreme Court on Monday directed the low-cost airline to invoke a bank guarantee of ₹270 crore to pay Maran towards the dues from the arbitral award of ₹572 crore.

The apex court also directed SpiceJet to pay ₹75 crore towards Maran's claim of ₹ 362 crore in interest dues.

The SC direction came after SpiceJet informed the court that it has paid ₹308 crore in cash against the pending amount of ₹579 crore and has given a bank guarantee of ₹270 crore to cover the rest of the amount.

The SC allowed SpiceJet to approach the Delhi High Court to argue for a lower interest.

SpiceJet's lawyer also told the court that Maran is free to reverse the transaction and take the airline back. Clarifying the matter, a

SpiceJet spokesperson later said: "With regard to the Supreme Court order in the matter relating to the dispute between SpiceJet and its former promoter Kalanithi Maran and his firm KALAirways, it is clarified that the overall amount in dispute is ₹578 crore of which ₹308 crore has already been deposited. The remaining amount of ₹270 crore is

2015 when Maran and his firm KAL Airways transferred 58.46% of the shares held by them to the present chairman of SpiceJet, Ajay Singh, for ₹2. Singh, who was the co-founder of the airline, had taken on the airline's liabilities valuing at



₹1,500 crore.

Through this share-transfer agreement, Maran was to be issued warrants and preference shares and had paid ₹679 crore towards the same.

In 2017, Maran moved the Delhi High Court saying that he was neither issued the preference shares as agreed upon nor

tribunal, in July 2018, awarded a refund to Maran to the tune of ₹579 crore-plus that SpiceJet accepted. However, interest, but rejected his claim

When Maran challenged this arbitration award before the High Court, the court favoured Maran and directed SpiceJet to deposit ₹243 crore towards the interest amount. This order of the High Court was stayed by the Supreme Court and came up for hearing on Monday with Maran seeking vacation of the stay order.



DEMAND FOR CARS and SUVs remained robust in January with volumes hitting a three-month high, dismissing predictions of subdued offtake following multiple price hikes as well as a jump in bank

interest rates. The total domestic passengervehicle (PV) wholesale volumes during January surged 17% year-on-year (y-o-y) to 346,382 units, according to data shared

Two-wheeler volumes rose

at 376,035 followed by motorcycles with sales of 771,621 units. Three-wheeler sales doubled to 48,903 units y-o-y during the reporting month. Vinod Aggarwal, president, SIAM said, "Better consumer



SC directs Bombay HC to speed up hearing in Finolex case

THE SUPREME COURT has asked the Bombay High Court to expedite the hearing in the Finolex group case, where a criminal petition was filed before the lower court, and to

complete it within six weeks. "In our considered opinion, interest of justice would be served by requesting the High Court to decide the writ petition no 1312 of 2021 and other connected matters expeditiously, preferably within a period of six weeks from the date of production of certified copy of this order positively without granting any unnecessary adjournments to either of the parties," the Supreme Court said in its

order earlier this month. The issue dates back to 2016, when a First Information Report (FIR) was filed against Orbit Electricals' director Prakash Chhabria and other directors by his cousin and Finolex Cables MD Deepak

Finolex CFO says business returning to pre-Covid levels

FINOLEX CABLES is seeing business return to the pre-Covid levels. "The growth rate is back, driving up volume for the company," CFO Mahesh Viswanathan said.

Finolex's December quarter revenues grew by 18% year-on-year to ₹1,150 crore, while net profit grew by 42% to ₹135 crore.

Meanwhile, an Orbit spokesperson said: "The Supreme Court vide its ex parte order dated 31.01.2023 has requested the HC to decide petitions filed by Prakash Chhabria and other parties. There is no order/direction for resolution of dispute. Further the SLP by Mr Deepak Chhabria was filed after an inordinate delay of 2 years without giving sufficient reasons. Since the matter is sub judice, at this stage it will be sufficient to mention that the order obtained from the SC by Deepak Chhabria is by suppressing material documents."

More money to go into new energy areas, says Thermax

ENERGYAND ENVIRONMENT company Thermax is entering a phase where its mix of work would change over the next couple of years with opportunities emerging in the climate and energy transition space, MD & CEO Ashish Bhandari said on Monday. More money will be going into new energy areas, he added.

Thermax created a new energy division two years ago towork on these areas. With the focus on new energy, Bhandari said, the company would be investing in new products engineering capability and people.

Investments will be made in

the green solutions business and the green solutions energy-as-a-service segment, including solar and biomassbased services. In the solar energy space, it targets to reach the 200 MW market next year and is also looking to enter the hybrid solar wind energy space

company had secured orders to the tune of ₹40-50 crore with leadership in areas such as municipal waste to CNG and biomass to CNG, Bhandari said. "The company has invested around ₹400 crore in the solar and bio-CNG energy services business. These would be profitable in the long term and have an expected rate of return of around 15%," he added.

In the area of bio-CNG, the

In its existing business, Thermax is seeing momentum in orders from the sugar, steel, cement, sugar, chemicals, pharma, and food and beverages sectors. Green solutions are also contributing to an increase in the order flow. The government capex push in the Budget and support to green technologies is expected to further spur the company's clean energy portfolio. Thermax saw an increase in

revenues, stabilisation of commodity prices and lower international freight costs, which enabled it to report a surge in profits and improve margins during the December quarter. Profit after tax was up 59% y-


