- 1. This certificate is issued in accordance with the terms of our engagement letter dated October 17, 2024.
- 2. We, Deloitte Haskins & Sells, Chartered Accountants, one of the Joint Statutory Auditors of Kotak Mahindra Bank Limited ("the Bank"), have been requested by the Management of the Bank to certify "Book Value of Assets of the Bank contained in Columns A to J of Statement on Security Cover as at September 30, 2024" (hereinafter referred together as the "Statement").

The Statement is prepared by the Bank from the unaudited books of accounts, unaudited financial results for the quarter and half year ended September 30, 2024 and other relevant records and documents maintained by the Bank pursuant to requirements of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (hereinafter referred together as the "SEBI Regulations"), as amended, for the purpose of submission to Bombay Stock Exchange/National Stock Exchange (the "Stock Exchanges").

Management's Responsibility

- 3. The preparation of the Statement is the responsibility of the Management of the Bank, including the preparation and maintenance of all accounting and other relevant supporting records and documents. This responsibility includes the design, implementation and maintenance of internal control relevant to the preparation and presentation of the Statement and applying an appropriate basis of preparation; and making estimates that are reasonable in the circumstances.
- 4. The Management of the Bank is responsible for ensuring that the Bank complies with all the relevant requirements of the SEBI Regulations and the Stock Exchanges.

Auditor's Responsibility

Our responsibility for the purpose of this certificate is to provide a limited assurance on whether the Book Value of Assets of the Bank contained in Columns A to J of Statement of Security Cover as at September 30, 2024 are in agreement with the unaudited books of accounts and other relevant records, unaudited financial results for the quarter and half year ended September 30, 2024 and documents maintained by the Bank. This did not include the evaluation of adherence by the Bank with all the applicable guidelines of the SEBI Regulations and the Stock Exchanges.
- 6. The engagement involves performing procedures to obtain sufficient and appropriate evidence to provide limited assurance on the Statement. The procedures performed for limited assurance vary in nature and timing from, and are less in extent than for, a reasonable assurance engagement. Consequently, the level of assurance obtained in a limited assurance engagement is substantially lower than the assurance that would have been obtained had a reasonable assurance engagement been performed.

kingly, we have performed the following procedures in relation to the Statement:

Obtained the Statement from the management.

- b) Traced the financial information contained in column A to J of the statement with the underlying unaudited books and records of the Bank for the half year ended September 30, 2024, as produced before us by the Management.
- c) We were not required to and have not performed any procedure on the information included in column K to O of the accompanying statement and the same is furnished by the management of the Bank. The statement only gives details of book value of assets and liabilities as the requirement for maintenance of security cover in respect of 'unsecured' non-convertible debt securities and a statutory auditor's certificate thereon is not envisaged.
- d) Made necessary inquiries with the management and obtained relevant representations in respect of matters relating to the Statement.
- 7. The unaudited financial results for the quarter and half year ended September 30, 2024, have been reviewed by us, on which we have issued unmodified conclusion vide our report dated October 19, 2024. Our review of the unaudited financial results was conducted in accordance with the Standard on Review Engagements ("SRE") 2410 'Review of Interim Financial Information Performed by the Independent Auditor of the Entity', issued by the Institute of Chartered Accountants of India (ICAI).
- 8. We conducted our examination and obtained the explanations in accordance with the Guidance Note on Reports or Certificates for Special Purposes issued by the ICAI. This Guidance Note requires that we comply with the ethical requirements of the Code of Ethics issued by the ICAI.

Independent Auditors' Review Report on unaudited standalone financial results for the quarter and half year ended 30 September 2024 of Kotak Mahindra Bank Limited pursuant to Regulation 33 and Regulation 52 read with Regulation 63(2) of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended.

To the Board of Directors of Kotak Mahindra Bank Limited

- 1. We have reviewed the accompanying Statement of unaudited standalone financial results of **Kotak Mahindra Bank Limited** (the "Bank") for the quarter and half year ended 30 September, 2024 (the "Statement"), being submitted by the Bank pursuant to the requirement of Regulation 33 and Regulation 52 read with Regulation 63(2) of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (the "Listing Regulations") except for the disclosures relating to consolidated Pillar 3 as at 30 September 2024, including leverage ratio, liquidity coverage ratio and net stable funding ratio under Basel III Capital Regulations as have been disclosed on the Bank's website and in respect of which a link has been provided in Note 7 of the Statement and have not been reviewed by us. We have initialled the Statement for identification purposes only.
- 2. This Statement, which is the responsibility of the Bank's Management and approved by the Board of Directors, has been prepared in accordance with the recognition and measurement principles laid down in Accounting Standard 25 "Interim Financial Reporting" ("AS 25"), prescribed under Section 133 of the Companies Act, 2013 read with relevant rules issued thereunder, in so far as they apply to Banks, the relevant provisions of the Banking Regulation Act, 1949, the circulars, guidelines and directions issued by the Reserve Bank of India ("RBI") from time to time (the "RBI Guidelines") and other accounting principles generally accepted in India, and in compliance with Regulation 33 and Regulation 52 read with Regulation 63(2) of the Listing Regulations. Our responsibility is to express a conclusion on the Statement based on our review.
- 3. We conducted our review of the Statement in accordance with the Standard on Review Engagements (SRE) 2410 'Review of Interim Financial Information Performed by the Independent Auditor of the Entity', issued by the Institute of Chartered Accountants of India. This standard requires that we plan and perform the review to obtain moderate assurance as to whether the Statement is free of material misstatement. A review is limited primarily to inquiries of bank's personnel and analytical procedures applied to financial data and thus provides less assurance than an audit. We have not performed an audit and accordingly, we do not express an audit opinion.
- 4. - 1. The above standalone financial results have been approved at the meeting of the Board of Directors held on 19th October, 2024. The results for the quarter and half year ended 30th September, 2024 were subjected to limited review by the joint statutory auditors (KKC & Associates LLP, Chartered Accountants (formerly Khimji Kunverji & Co LLP) and Deloitte Haskins & Sells, Chartered Accountants) who have issued unmodified review report thereon. The previous period results were reviewed/audited by the joint statutory auditors (KKC & Associates LLP, Chartered Accountants (formerly Khimji Kunverji & Co LLP) and Price Waterhouse LLP, Chartered Accountants).
- Other Income includes non-fund based income such as commission earned from guarantees / letters of credit, financial advisory fees, selling of third party products, general banking fees, earnings from foreign exchange transactions, profit / (loss) (including revaluation) from sale and revaluation of eligible category of investments.
- During the quarter, the Bank has not granted any options under employee stock option scheme. The Bank has allotted 1,68,714 equity shares during the quarter pursuant to the exercise of options and 4,050,895 stock options were outstanding with employees of the Bank and its subsidiaries as at 30th September, 2024.
- 4. Provisions and contingencies are net of recoveries made against loan accounts which have been written off as bad. "Provision and contingencies" includes reversal of provision of ₹ 9.33 crore for the quarter & half year ended 30th September, 2024 (provision of ₹ Nil for the quarter ended 30th June, 2024 and ₹33.13 crore for the year ended 31st March, 2024) on applicable Alternate Investments Funds (AIF) Investments pursuant to RBI circulars dated 19th December, 2023 and 27th March, 2024.
- 5. On 18th June, 2024, the Bank has completed the divestment of 70% stake (through a combination of fresh growth capital and share sale) in its subsidiary Kotak Mahindra General Insurance Company Limited ("KGI") to Zurich Insurance Company Limited ("Zurich"). The Bank sold 553,181,595 equity shares of KGI for a consideration of ₹ 4,095.82 crore, resulting in net gain from such sale of ₹ 3,519.90 crore (pretax) which has been disclosed as an exceptional item in the results. The Bank continues to hold the remaining 30% of the share capital of KGI as at 30th September, 2024. Consequent to this sale, KGI ceases to be a subsidiary of the Bank and became an Associate with effect from 18th June, 2024.

- 1. We have reviewed the accompanying statement of unaudited consolidated financial results of **Kotak Mahindra Bank Limited** (the "Parent" or the "Bank"), its subsidiaries (the Parent and its subsidiaries together referred to as 'the Group') and its share of the net profit after tax of its associates for the quarter and half year ended 30 September 2024 (the "Statement"), being submitted by the Bank pursuant to the requirements of Regulation 33 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (the "Listing Regulations"), except for the disclosures relating to consolidated Pillar 3 as at 30 September 2024, including leverage ratio, liquidity coverage ratio and net stable funding ratio under Basel III Capital Regulations as have been disclosed on the Bank's website and in respect of which a link has been provided in Note 8 of the Statement and have not been reviewed by us. We have initialled the Statement for identification purposes only.
- 2. This Statement, which is the responsibility of the Bank's Management and has been approved by the Bank's Board of Directors, has been prepared in accordance with the recognition and measurement principles laid down in Accounting Standard 25, Interim Financial Reporting ("AS 25"), prescribed under Section 133 of the Companies Act, 2013 read with relevant rules issued thereunder, in so far as they apply to Banks, the relevant provisions of the Banking Regulation Act, 1949, the circulars, guidelines and directions issued by the Reserve Bank of India ("RBI") from time to time (the "RBI Guidelines") and other accounting principles generally accepted in India, and in compliance with Regulation 33 of the Listing Regulations. Our responsibility is to express a conclusion on the Statement based on our review.
- 3. We conducted our review of the Statement in accordance with the Standard on Review Engagements (SRE) 2410 'Review of Interim Financial Information Performed by the Independent Auditor of the Entity' issued by the Institute of Chartered Accountants of India. A review of interim financial information consists of making inquiries, primarily of Bank's personnel responsible for financial and accounting matters, and applying analytical and other review procedures. A review is substantially less in scope than an audit conducted in accordance with the Standards on Auditing specified under Section 143 (10) of the Companies Act, 2013, and consequently does not enable us to obtain assurance that we would become aware of all significant matters that might be identified in an audit. Accordingly, we do not express an audit opinion.

We also performed procedures in accordance with the circular issued by the Securities and Exchange Board of India under Regulation 33(8) of the Listing Regulations, as amended, to the extent applicable.

We did not review/audit the interim financial results of 4 subsidiaries, included in the Statement, whose interim financial results reflects total assets of ₹ 1,45,570.50 crore (before consolidation adjustments) as at 30 September 2024 and total revenues of ₹ 9,414.43 crore and ₹ 17,571.71 crore (before consolidation adjustments) for the quarter and half year ended 30 September 2024 respectively and total net profit after tax of ₹ 930.93 crore and ₹ 1,618.09 crore (before consolidation adjustments) for the quarter and half year ended 30 September 2024 respectively, and cash outflows (net) of ₹ 200.81 crore (before consolidation adjustments) for the half year ended 30 September 2024. These interim financial results have been reviewed/audited by other auditors whose review/audit reports have been furnished to us by the Parent's Management, and our conclusion on the Statement in so far as it relates to the amounts and disclosures included in respect of these subsidiaries, is based solely on the review/audit reports of such other respective auditors, and the procedures performed by us as stated in paragraph 3 above.

The unaudited interim financial results of one subsidiary included in the Statement, whose interim financial results reflects total assets of ₹ 32,436.89 crore (before consolidation adjustments) as at 30 September 2024 and total revenues of ₹ 1,379.79 crore and ₹ 2,678.25 crore (before consolidation adjustments) for the quarter and half year ended 30 September 2024 respectively and total net profit after tax of ₹ 444.24 crore and ₹ 844.59 crore (before consolidation adjustments) for the quarter and half year ended 30 September 2024 respectively, and cash flows (net) of ₹ 1,483.15 crore (before consolidation adjustments) for the half year ended 30 September 2024, has been reviewed by one of the joint auditors, whose review report has been furnished to us by the Parent's Management. Accordingly, conclusion of one of the joint auditors, KKC & Associates LLP (Formerly Khimji Kunverji & Co LLP) on the Statement in so far as it relates to the amounts and disclosures included in respect of this subsidiary, is based solely on the review report of the other joint auditor, and the procedures performed by us as stated in paragraph 3 above.

Our conclusion on the Statement is not modified in respect of these matters.

NOTES:

- The consolidated financial results are prepared in accordance with Accounting Standard 21 (AS-21) "Consolidated Financial Statements" and Accounting Standard – 23 (AS-23) "Accounting for investment in associates in Consolidated Financial Statements" specified under section 133 and relevant provisions of Companies Act, 2013.
- 2. These consolidated financial results have been prepared in accordance with the recognition and measurement principles laid down in Accounting Standards notified under Section 133 and the relevant provisions of the Companies Act, 2013 read with the Companies (Accounting Standards) Rules, 2021 in so far as they apply to the Group and the guidelines issued by the Reserve Bank of India (RBI), Insurance Regulatory and Development Authority of India (IRDAI) from time to time as applicable and the generally accepted accounting principles prevailing in India. The financial results of Indian subsidiaries and associates (excluding insurance companies) are prepared as per Indian Accounting Standards in accordance with the Companies (Indian Accounting Standards) Rules, 2015. The financial results of subsidiaries located outside India are prepared in accordance with accounting principles generally accepted in their respective countries. However, for the purpose of preparation of the consolidated financial results, the results of subsidiaries and associates are prepared in accordance with Generally Accepted Accounting Principles in India ('GAAP') specified under Section 133 and relevant provision of Companies Act, 2013 read with Companies (Accounting Standard) Rules, 2021.
- 3. The above consolidated financial results were approved at the meeting of the Board of Directors held on 19th October, 2024. The results for the quarter and half year ended 30th September, 2024 were subjected to limited review by the joint statutory auditors (KKC & Associates LLP, Chartered Accountants (formerly Khimji Kunverji & Co LLP) and Deloitte Haskins & Sells, Chartered Accountants) of the Bank who have issued an unmodified review report thereon. The previous period results were reviewed/audited by the joint auditors (KKC & Associates LLP, Chartered Accountants (formerly Khimji Kunverji & Co LLP) and Price Waterhouse LLP, Chartered Accountants).
- 4. Other income includes non-fund based income such as commission earned from guarantees / letters of credit, financial advisory fees, selling of third party products, general banking fees, earnings from foreign exchange transactions, profit / (loss) from sale and revaluation (other than insurance business) of eligible category of investments.
- 5. The change in the valuation of liabilities for life policies in force, lapsed policies that are likely to be revived in future and for policies in respect of which premium has been discontinued but liability exists, for the quarter and half year ended 30th September, 2024 amounting to ₹3,603.01 crore and ₹6,902.47 crore respectively (₹3,299.46 crore for the quarter ended 30th June, 2024 and ₹2,387.50 crore and ₹5,290.56 crore for the quarter and half year ended 30th September, 2023, and ₹14,922.60 crore for the year ended 31st March, 2024), have been included in "Policy holders' reserves, surrender expenses and claims" under "Operating Expenses" in the above Financial Information.
- 6. Provisions and contingencies are net of recoveries made against loan accounts which have been written off as bad. "Provisions and contingencies" includes reversal of provision of ₹ 9.33 crore for the quarter and half year ended 30th September, 2024 (provision of ₹ Nil for the quarter ended 30th June, 2024 and ₹ 33.13 crore for the year ended 31st March, 2024) on applicable Alternate Investments Funds (AIF) Investments pursuant to RBI circulars dated 19th December, 2023 and 27th March, 2024.
- 7. On 18th June 2024, the Bank has completed the divestment of 70% stake (through a combination of fresh growth capital and share sale) in its subsidiary Kotak Mahindra General Insurance Company Limited ("KGI") to Zurich Insurance Company Limited ("Zurich"). The Bank sold 553,181,595 equity shares of KGI for a consideration of ₹ 4,095.82 crore resulting in net gain from such sale of ₹ 3,803.40 crore (pre-tax) considering the carrying value of investment in consolidated financials. Profit on sale of shares of KGI has been disclosed as an exceptional item in the results. The Bank continues to hold the remaining 30% of the share capital of KGI as at 30th June, 2024. Consequent to this sale, KGI ceases to be a subsidiary of the Bank and became an Associate with effect from 18th June, 2024.
- 8. In accordance with the RBI guidelines, Banks are required to make consolidated Pillar 3 disclosures including leverage ratio, liquidity coverage ratio and Net Stable Funding Ratio (NSFR) under the Basel III Framework. These disclosures are available on the Bank's website at the following link: https://www.kotak.com/en/investor-relations/financial-results/regulatory-disclosure.html. These disclosures have not been subjected to audit or limited review.





- 9. During the quarter ended 30th June, 2024, the Bank has implemented the Master Direction Classification, Valuation and Operation of Investment Portfolio of Commercial Banks (Directions), 2023 dated 12th September, 2023 which is applicable to banks from 1st April, 2024. Consequent to the transitions provisions, the Bank's networth and investments have increased by ₹ 2,905.46 crore (post tax) and ₹3,283.11 crore (pre-tax) respectively as on 1st April, 2024 on account of revision in the carrying value to the fair value as on such date. Subsequent changes in fair value of performing investments under Available for Sale (AFS) and Fair Value Through Proft and Loss ('FVTPL') (including Held For Trading ('HFT')) categories have been recognised through AFS reserve and Profit and Loss Account respectively. Accordingly, the amounts for periods prior to 1st April, 2024 are not comparable. The Group entities other than Bank, continue to follow AS -13 "Accounting for Investments" and IRDA guidelines, as applicable. The total proportion of investments for which subsidiaries have applied accounting policies different from the Bank is approximately 11.22% of the total investments as at 30th September, 2024 (excluding investments attributable to policy holders of Insurance subsidiary).
- 10. On 18th October, 2024, the Bank entered into a definitive agreement with Standard Chartered Bank, India for acquisition of its Personal Loan book (total loan outstanding of approx. ₹ 4,100 crore as of 30th September, 2024). The above transaction is subject to regulatory and other approvals and the satisfaction or waiver of customary closing conditions. The Bank will acquire the Personal Loan book that will be outstanding closer to the completion date.
- 11. There has been no change in the significant accounting policies during the quarter and half year ended 30th September, 2024 as compared to those followed for the year ended 31st March, 2024 except as disclosed in note 9.
- 12. Figures for the previous periods / year have been regrouped / reclassified wherever necessary to conform to current period's presentation.
