NOTICE TO EQUITY SHAREHOLDERS OF THE COMPANY

This Notice is given pursuant to the circular issued by the Securities and Exchange Board of India ("SEBI") dated 3rd November, 2021. SEBI has notified Common and Simplified Norms for processing investor's service request by Registrar and Share Transfer Agent ("RTA") and norms for furnishing PAN, KYC details and Nomination for shareholders holding shares in physical mode.

The shareholders holding shares in physical mode are requested to furnish details of valid PAN linked with Aadhaar, email address, mobile number, bank account details and nomination. The folios wherein any one of the cited document / details are not available on or after 1st April, 2023, shall be frozen by the Company and you will not be eligible to lodge grievance or avail service request from the RTA and not eligible for receipt of dividend in physical mode.

As required by the Income Tax Authorities, please link your PAN and Aadhaar by 31* March, 2022 or any other date as may be specified by the Central Board of Direct Taxes ("CBDT") if not linked earlier, to avoid freezing of your folio. The folios in which PAN is not valid as on the notified cut-off date i.e 31* March, 2022 or any other date as may be specified by CBDT, shall be frozen by the Company.

Please also note that after 31st December, 2025, the frozen folios shall be referred by the Company to the administering authority under the Benami Transactions (Prohibitions) Act, 1988 and / or Prevention of Money Laundering Act, 2002.

The SEBI circular has also prescribed various forms like form ISR-1 (for availing investor services), form ISR-2 (Confirmation of Signature of securities holder by the Banker), form ISR-3 (Declaration to Opt-out of Nomination), form ISR-4 (Request for issue of duplicate certificate and other service requests) form SH-13 (Nomination) and form SH-14 (cancellation/ updation of nominee) which needs to be filled by the shareholders and submitted to the RTA of the Company for all the requests mentioned in the circular.

Also, a letter on the above mentioned SEBI Circular has been sent by the Company to the holders of physical shares.
