I, Vidyadhar V. Chakradeo, of M/s. V. V. Chakradeo & Co. 2. The Company has provided the remote e-voting facility to the Members to exercise their vote electronically through the e-voting service facility of the Company's Registrar and Share transfer Agent, Link Intime India Private Limited ('LIPL').
3. The members of the Company holding shares as on the "Cut-off" date of Friday, December 17, 2021 were entitled to vote.
4. The voting through electronic mode had commenced on Wednesday, December 22, 2021 (from 9.00 a.m.) and ended on Friday, January 21, 2022 (at 5 00 p m).
5. The Postal Ballot Register was prepared to record equity shareholder's assent or dissent received, mentioning the particulars of name, address, folio number or client ID of the shareholders, number of shares held by them.
6. E-votes received were scrutinized and reconciled with the records maintained by Registrar and Share Transfer Agent (RTA).

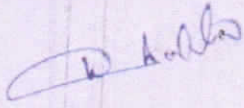

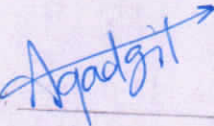

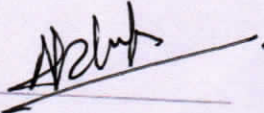
