Farooq Abdullah and Omar Abdullah, who were released from detention in March, have held a series of meetings since their release. The two were among three chief ministers and hundreds of people detained as part of sweeping measures taken to prevent protests against the constitutional changes to Jammu & Kashmir's status last year. On Thursday, the PDP took out a protest rally from its party office against human rights violations and for the release of political leaders. The newly-launched Apni Party has also held a meeting and demanded the restoration of the statehood. Bharatiya Janata general secretary Ram Madhav held a series of meetings with the leaders of his and other parties during his visit to Kashmir on Thursday.

Sitharaman on Thursday said the economy has been hit by the pandemic, which is an 'Act of God', and it will see a contraction
