**Sub: Intimation under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 w.r.t. Disruption of operations due to flooding and rain at the place of Registered Office of the company.**

**Dear Sir/Madam,**

In terms of Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we would like to inform you that the business operations at the Company's Registered Office located at Naraingarh Road, Village Garnala, Ambala City- 134003 HR were temporarily disrupted owing to flooding and water logging at the office premises by massive rain, (approx. 500mm) in Ambala during 8<sup>th</sup> July, 2023 to 11<sup>th</sup> July, 2023, which led to a flood crisis throughout the entire region.

The Machinery, plants and equipment, hardware and software, furniture, documents were submerged and hence damaged. The Company is taking adequate measures and is in the process of repairing, reviving and retrieving the same. We are trying to assess the losses and are hopeful that they would not be on a higher side.

We resumed the normal operations at site from today, i.e. 27<sup>st</sup> July 2023.
