Rotary Club of Madras gives COVID kits to CM

Chennai, June 30: The Rotary Club of Madras hands over Covid program assets valued at around "2.3 Crore" to Honourable Chief Minister of Tamil Nadu, Mr. M.K.Stalin. All these assets are organized and supported by CSR funds, Individual Donors & Rotarians.
