Sub: Warning in relation to non-compliance with the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('LODR Regulations')

- 1. This has reference to the inquiry report shared by Registrar of Companies, vide letter dated November 24, 2020, *inter alia* including observations on resignation by two women directors Ms. Uma Agarwal and Ms. Shikha Rai.
- 2. Upon examination, it has been noted that the appointment of Ms. Uma Agarwal was as non-executive and non-independent director, which was also mentioned in the corporate governance report for the quarter ended June 30,2018. However, in the corporate announcement dated April 16,2018, the appointment of Ms. Uma Agarwal was mentioned as a woman director in the non-executive and independent category.
- 3. Further, Ms. Shikha Rai was appointed as non-executive and non-independent director of the Company and the same was disclosed in the corporate governance report for the quarter ended September 30, 2018. However, the disclosure made for the outcome of Annual General Meeting held on September 28, 2018 mentioned her appointment as director and a non-executive professional director of the Company.
- 4. In view of the above, the disclosures made on the stock exchange websites are not consistent. The same is viewed seriously and you are hereby warned for the failure in ensuring compliance with regulation 4(1)(e) of LODR Regulations. Accordingly, you are hereby advised to be cautious in future and ensure that disclosures made on the stock exchange websites are adequate and accurate.
- 5. Further, it is advised to place this letter before the board of directors of the Company and to disseminate the same to the stock exchanges immediately.
