Dhoni moves HC for contempt proceedings against IPS officer

CHENNAI: Cricketer MS Dhoni has moved the Madras High Court to initiate contempt proceedings and issue summons to IPS officer G Sampath Kumar for his alleged statements against the Supreme Court and certain senior counsels in the matter

pertaining to match-fixing.
The case was listed, but was not heard on Friday.

In 2014, Mr Dhoni filed a civil suit to permanently re-strain Mr Sampath Kumar, who was the then inspector general of police, from mak-ing any statement linking him (Mr Dhoni) to match-fix-ing and spot-fixing of match-



es. He prayed the court to direct him to pay ₹100 crore to-wards damages.

By an interim order passed

on March 18, 2014, the court restrained Mr Sampath Ku-mar from making any state-ment against Mr Dhoni. Despite the order, Mr Sampath Kumar allegedly filed an affi-davit before the Supreme Court containing disparag-

ciary and the senior counsel representing the State in the cases against him. When it cases against him. When it was brought to the notice of the Madras High Court, it took the same on its file in December, 2021.
After obtaining consent from Advocate-General R

from Advocate-General R Shanmugasundaram on July 18 this year to file the con-tempt plea, Mr Dhoni pre-ferred the present contempt plea on Oct 11, 2022, to punish Mr Kumar for his alleged action of making remarks against the judiciary in vio-lation of the court's interim order passed in 2014. —PTI

PIL over removal of Ganguly as BCCI boss

KOLKATA: A public interest litigation (PIL) has been filed in the Calcutta High Court against the removal of former Indian cricket team captain Souray Ganguly as the Board of Control for Cricket in India president, The PIL by advocate Ramaprasad Sarkar is likely to be heard on Tuesday.

Mr Sarkar's argument is that Mr Ganguly was removed from the BCCI chief's post despite there was a clear order from the Supreme Court that he could continue in that chair for another three years. "The apex another three years. The apex court order also cleared the way for Mr Jay Shah to continue as BCCI secretary for three more years till 2025. However, despite Mr Shah continuing to remain in his chair, Mr Ganguly was removed," he said. —IANS
