# Dhoni moves HC for contempt proceedings against IPS officer

**CHENNAI:** Cricketer MS Dhoni has moved the Madras High Court to initiate contempt proceedings and issue summons to IPS officer G Sampath Kumar for his alleged statements against the Supreme Court and certain senior counsels in the matter pertaining to match-fixing.

The case was listed, but was not heard on Friday.

In 2014, Mr Dhoni filed a civil suit to permanently restrain Mr Sampath Kumar, who was then the inspector general of police, from making any statement linking him (Mr Dhoni) to match-fixing and spot-fixing of match-



ing remarks against the judiciary and the senior counsel representing the State in the cases against him. When it was brought to the notice of the Madras High Court, it took the same on its file in December, 2021.

After obtaining consent from Advocate-General R Shanmugasundaram on July 18 this year to file the contempt plea, Mr Dhoni preferred the present contempt plea on Oct 11, 2022, to punish Mr Sampath Kumar for his alleged action of making remarks against the judiciary in violation of the court's interim order passed in 2014. —PTI

**PIL over removal of Ganguly as BCCI boss**

**KOLKATA:** A public interest litigation (PIL) has been filed in the Calcutta High Court against the removal of former Indian cricket team captain Sourav Ganguly as the Board of Control for Cricket in India president. The PIL by advocate Ramaprasad Sarkar is likely to be heard on Tuesday.

Mr Sarkar's argument is that Mr Ganguly was removed from the BCCI chief's post despite there was a clear order from the Supreme Court that he could continue in that chair for another three years. "The apex court order also cleared the way for Mr Jay Shah to continue as BCCI secretary for three more years till 2025. However, despite Mr Shah continuing to remain in his chair, Mr Ganguly was removed," he said. —IANS
