

France's Louvre museum gets its first woman boss in history

France's Louvre Museum has named its first female director, Dr. Laurence Ripstein, in a move seen as a landmark for the world's most visited museum. Ripstein, 57, is a French art historian and curator who has worked at the Louvre for over 20 years. She will take over from Jean-Louis Falautou, who has led the museum since 2014. Ripstein's appointment is a significant milestone for the Louvre, which has been led by men since its founding in 1793. She will be responsible for the museum's overall strategy and operations, as well as its financial and administrative affairs. Ripstein is expected to start her new role in June 2021.

- The financial results have been prepared in accordance with Indian Accounting Standards (Ind-AS) as prescribed under Section 133 of the Companies Act, 2013 ("the Act") read with rule 3 of the Companies (Indian Accounting Standards) Rules, 2015 and relevant amended thereon. The standalone and consolidated financial results of the Company will be available on the website of ISE (www.iseindia.com) and on Company's website (www.daaawat.com).
 - The Company and its subsidiary (the "Group") are primarily engaged in the business of manufacturing, trading and marketing of rice which is a single primary reportable segment as per Indian Accounting Standard ("Operating Segment") ("IAS 108"), which is in line with nature of operating, result by itself operating decision maker.
 - The Group has insurance claim recoverable classified into non-current assets amounting to ₹1,610.83 lakhs as at March 31, 2021. The claim is attributable to the loss of raw material, incurred by the Group, due to major fire which had occurred in the warehouse premises of the subsidiary Company in India in FY 2018-19. The Group had recognized the insurance claim recoverable amounting to ₹1,610.83 lakhs in FY 2019-20. Based on management's assessment of loss amount and positive outcome to the insurance reports that submitted by the Insurance Agency. Later on, the Insurance Agency repudiated the insurance claim with its order dated February 6, 2020, against which the subsidiary Company had filed a civil suit with District Court of Raigarh, Chhattisgarh, the outcome of which is pending. On the basis of developments in the case including the insurance report substantiated by survey report submitted by the Insurance Agency during the initial phase and which was the basis for the Group to recognize such asset, the Group had written off claim amounting to ₹4,400 lakhs in FY 2019-20. The Group, based on management's assessment of facts of the case and upon obtaining the relevant legal counsel, has concluded that it holds merits and good probability to win the case, as the claim has already been repudiated.
 - The Group is engaged into the business of manufacturing and selling rice and therefore, its business falls under the category to provide essential services. Due to the lock-downs and other restrictions and conditions related to the COVID-19 pandemic, the State Government has granted permission to the Group to run its operations and expand its retail operations/retail outlets the date of approval of this statement. The Group is very well equipped with a robust supply chain network and has no shortage with respect to raw material, including stock of paddy and rice, to fulfil the demand from both retail and intervention at markets. The Group has implemented A+B strategic strategies for the health and wellness of its employees/retailers and plans to continue operating with all necessary adherence to the guidelines issued by the respective authorities. Based on management's assessment of the impact on Group's operations, financial performance and position as at and for the year ended March 31, 2021, it has been concluded that there is no impact which is required to be recognized in these financial statements. Accordingly, the adjustments have been made to these financial statements.
 - The above financial results were reviewed by the Audit Committee and approved by the Board of Directors on May 26, 2021.
 - The figures of last quarter on the Standalone figures, Standalone audited figures in respect of the full financial year ended March 31, 2021 and the unaudited published year to date figures upto December 31, 2020, being the date of the end of the financial year which were subjected to limited review.
 - Previous period's figures have been regrouped / reclassified wherever necessary to correspond with the current period's classification / disclosure.
