Dear Sirs,

Under Rule 30 of Schedule III Part A of SEBI (LODR) Regulations, we wish to make the following disclosures:

On the evening of 19th June 2020, Bonded Warehouse of the company has been sealed by the Excise Authorities of Government of Puducherry on the ground that during an inspection of the Warehouse, a few bottles of IMFL were seen without / inadequate Holograms. This has brought the bottling operations of the Company to a halt. The Company has been also issued a Show Cause Notice to explain the violation of Excise Rules regarding affixation of Holograms and time was granted up to 6th July 2020 for furnishing explanation. We have given our explanation pointing out that the Hologram affixation is done by contract employees of the Company under the direct supervision and control of the Excise Department Officials who are posted in the Distillery and that the Company cannot be held liable for any violation of Rules in this regard, and further that responsibility in the regard rests with the Department Officials.

Further, even before the expiry of the time allowed for furnishing explanation, FIRs have been lodged against the Key Management Personnel of the Company and following this, Mr. R.V. Ravikumar, Managing Director and Mr. B. Rangabashyam, General Manager have been placed under custodial interrogation and enlarged on bail. Aggrieved by the vindictive harassment against the Company and its officials, the Company is taking appropriate legal steps to have the FIRs quashed and to have the restrictions on the operations of the Company removed.
