#### औद्योगिक उत्पादन 3.1 प्रतिशत बढा

नई दिल्ली, भाषा। विनिर्माण क्षेत्र के बेहतर प्रदर्शन की वजह से देश का ओद्योगिक उत्पादन (आईआईपी) सितंबर में 3.1 प्रतिशत बढ़ा है। खनन, विनिर्माण और बिजली उत्पादन में सुधार से ओद्योगिक उत्पादन बढ़ा है। मंगलवार को जारी आधिकारिक आंकड़ों से यह जानकारी मिली है।

सितंबर, 2023 में औद्योगिक उत्पादन की वृद्धि दर 6.4 प्रतिशत रही थी। हालांकि इस साल अगस्त में औद्योगिक उत्पादन में 0.1 प्रतिशत की गिरावट आई थी जिसकी मुख्य वजह देश के विभिन्न हिस्सों में बाढ़ के कारण खनन कार्य प्रभावित होना था। राष्ट्रीय सांख्यिकी कार्यालय (एनएसओ) की ओर से जारी आंकड़ों के अनुसार, सितंबर, 2024 में खनन क्षेत्र का उत्पादन 0.2 प्रतिशत विनिर्माण उत्पादन ३,० प्रतिशत और बिजली उत्पादन 0.5 प्रतिशत बढ़ा। अगस्त में खनन क्षेत्र का उत्पादन 4.3 प्रतिशत और बिजली उत्पादन 3.7 प्रतिशत घटा था. जबकि विनिर्माण क्षेत्र की वद्धि दर भी सिर्फ 1.1 प्रतिशत रही थी। एनएसओ के बयान के अनसार, '' सितंबर, 2024 के लिए आईआईपी वृद्धि दर 3.1 प्रतिशत रही है. जबकि अगस्त, 2024 में औद्योगिक

### विकासशील देशों को बाकू से खाली हाथ नहीं लौटना चाहिए: गुतारेस

बाकू, भाषा। संयुक्त राष्ट्र महासचिव एंतानियो गुतारंस ने मंगलवार को विश्व नेताओं से यह सुनिश्चित करने का आग्रह किया कि सीओपी में जलवायु वित्त की अड़चनें दूर हों, तथा चेतावनी दी कि विकासशील देशों को बाकू से खाली हाथ नहीं लोटना चाहिए। यहां सीओपी29 विश्व नेताओं के जलवायु कार्रवाई शिखर सम्मेलन के उद्घाटन समारोह को संबोधित करते हुए गुतारंस ने विकासशील देशों को सहाय देने के लिए तत्काल उथाय करने की मांग की, जो वैश्विक उत्सर्जन में अपेक्षाकृत कम हिस्सेदारी होने के बावजूद जलवायु-जनित आपदा का मामियाजा भाग रहे हैं।

गुतारेस ने कहा, समस्या अमीर लोगों द्वारा पेदा की जाती है, तथा गरीब लोग इसकी सबसे अधिक कीमत चुकाते हैं। उन्होंने कहा विकासशील देशों को जलवायु परिवर्तन के कारण खाद्य असुरक्षा, बुनियादी ढांचे की क्षति तथा जेव विविधता की हानि जेसे असंगत प्रश्नका सामना करना पड़ता है। उन्होंने कहा, विकासशील देशों को बाकु से खाली हाथ नहीं लौटना चाहिए। समझौता होना जरूरी है और परा भरोसा है कि यह हो जाएगा।

# खुदरा मुद्रास्फीति अक्टूबर में बढ़कर 6.21 प्रतिशत पर, 14 माह का उच्चस्तर

उपभोक्ता मृत्य सूचकांक आधारित मृद्रास्फीति अक्टूबर में बढ़कर 6.21 प्रतिशक्त हो गई, जो इससे पिछले महीने यानी सितंबर में 5.49 प्रतिशत थी। मंगलवार को जारी आधिकारिक आंकड़ों के अनुसार, मृद्धक रूप से खाद्य वस्तुओं के दाम बढ़ने से खुदरा मृद्रास्फीत बढ़ी है। इस तरह खुदरा मृद्रास्फीत भारतीय रिजर्व बेंक (आरबीआई) के छह प्रतिशत के संतीपजनक स्तर के

पिछले साल इसी महीने में उपभोक्ता मूल्य सूचकांक (सीपीआई) आधारित मुद्रास्फीत 4.87 प्रतिशत थी।

राष्ट्रीय सांख्यिको कार्यालय (एनएसओ) के आंकड़ों से पता चलता है कि खाद्य वस्तुओं की मुद्रास्फीति अक्टूबर में बढ़कर
