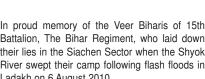

The notification added that the move was aimed at curbing the menace of waste such as tiles, construction blocks, bricks, and other material thrown on either the roadside or open plots which leads to the infestation of mice, insects and reptiles, creating a nuisance for the people living close-by. Such spots also pose danger to public health as they can become a source of several diseases.

"Additionally, RMC has to incur huge expenditures to remove the accumulated waste, resulting in the wastage of man-hours. The illegal activity is continued at the expense of the safety and the health of people. Therefore, it is prohibited by the provisions in Annexure C, Chapter 14 of the Gujarat Provincial Municipal Corporation Act (1949)," noted the notification.

It further stated that C&D waste management cells have been set up in all three zones of the city, and that Town Planning Officer MD Sagathiya and Environmental Engineer Nilesh Parmar have been asked to oversee the implementation of the new rule. The RMC will also help city residents in arranging vehicles to transport and dispose of the C&D waste.

Residents can dial RMC's callcentre number (0281-2450077) to hire vehicles by paying Rs 300 per chhakado-rickshaw load of C&D, Rs 500 for a tractor-trailer load and Rs 1,000 per truckload. The notification added that people will be free to sort, transport and use materials from the C&D waste management centres.
