Pursuant to Regulation 30 read with Schedule III Part A Para A (7) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('SEBI LODR'), we wish to inform you that Dr. Richard Rupp (DIN: 02205790), Dr. S. Sivaram (DIN: 00009900) and Shri Sudhir Mankad (DIN: 00086077), were re-appointed as Independent Directors for a second term of three years with effect from August 8, 2019 to August 7, 2022.

Accordingly, upon completion of second term of appointment as Independent Directors, Dr. Richard Rupp, Dr. S. Sivaram and Shri Sudhir Mankad, ceased to be Independent Directors of the Company with effect from August 8, 2022.

The Shareholders of the Company and Stock Exchanges were informed earlier that upon recommendations of the Nomination and Remuneration Committee of the Company, the Board of Directors of the Company at their Meeting held on 3<sup>rd</sup> May, 2019 had recommended the re-appointment of said Independent Directors for the second term of three consecutive years, to the Shareholders for passing respective Special Resolutions.

The Notice convening 48<sup>th</sup> Annual General Meeting ('AGM') of the Company, which contains the Special Resolutions and Explanatory Statements wherein the date of re-appointment for second term of three consecutive years i.e. w.e.f. 8<sup>th</sup> August, 2019 and date upto which the said Directors shall remain Independent Directors i.e. upto 7<sup>th</sup> August, 2022, was filed with the Stock Exchanges on 3<sup>rd</sup> June, 2019 and the said Notice was also circulated to the Shareholders of the Company, alongwith the 48<sup>th</sup> Annual Report of the Company.

Further, the respective reappointments of the said Independent Directors for second term of three consecutive years were approved by the shareholders at the 48<sup>th</sup> AGM held on 28<sup>th</sup> June, 2019 and the outcome of the 48<sup>th</sup> AGM was intimated to the Stock Exchanges on 29<sup>th</sup> June, 2019.

In view of the above and since the Independent Directors can not be reappointed for further period after completion of their second term, the information about date of cessation of the
