FOR THE HALF YEAR ENDED MARCH 31, 2019

We have examined all Share Transfer Deeds, Memorandum of Transfers, Registers, files and other documents relating to I G Petrochemicals Limited ("The Company") as maintained by M/s. Bigshare Services Pvt. Ltd., the Registrar and Share Transfer Agent, pertaining to transfer of Equity Shares of the Company for the period from October 1, 2018 to March 31, 2019 for the purpose of issuing a Certificate as per Regulation 40(9) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015. Based on the information provided and confirmed by Registrar and Share Transfer Agent, we hereby certify that during half year ended on March 31, 2019:

- A) The Company has received 112 (One Hundred and Twelve) request for transfer of shares covering 12900 Equity Shares. Except 17 (Seventeen) request covering 1850 Equity Shares, *all the Share Certificates relating to the transfer of Shares received by the Company, as entered in the Memorandum of Transfers, were processed and issued after 15 days from the date of lodgment of each deed for transfer;*
- B) The Company has received 17 (Seventeen) request covering 2200 Equity Shares for Transmission of shares.
