Pursuant to Regulation 30 (2) of Securities and Exchange Board of India (Listing Obligations & Disclosure Requirements) Regulations, 2015 (LODR) and in accordance with the requirements of sub-clause 16(g) of Para A of Part A of Schedule III of LODR, we wish to inform that based on deliberations in the 15<sup>th</sup> meeting of Committee of Creditors held on 17 September 2020 regarding change in statutory auditors, existing statutory auditor (DTS & Associates LLP) has vide letter dated 28 September 2020, tendered their resignation as statutory auditors of the company before the completion of their term. The resignation is to take effect immediately. The detailed reasons for resignation are given in the attached letter.

Pursuant to Regulation 30 (2) of Securities and Exchange Board of India (Listing Obligations & Disclosure Requirements) Regulations, 2015 (LODR) and in accordance with the requirements of sub-clause 16(g) of Para A of Part A of Schedule III of LODR, we wish to inform that the 15<sup>th</sup> CoC meeting of Jet Airways (India) Ltd was held on September 17, 2020 and in the e-voting concluded on September 24, 2020, wherein the CoC Members passed a resolution under section 28(1)(m) of the Insolvency & Bankruptcy Code and pursuant to the provisions of Section 139 (6) and other applicable provisions, if any, of the Companies Act, 2013 and the Rules made thereunder (including any statutory modification(s) or re-enactment thereof) to replace the existing statutory auditors of Jet Airways (India) Limited with Sharp & Tannan Associates (Firm Registration No 109983W)

Also, certain regular CIRP matters were discussed and approved by the members in the said meeting.
