YES BANK FRAUD SC stays HC order granting bail to DHFL promoters

FE BUREAU New Delhi, September 3

The SUPREME COURT on Thursday stayed the bail order granted by Bombay High Court to Devraj Housing Finance Corporation (DHFL) promoters Kapil Wadhawan and Dhruva Wadhawan (captured) till October 7 in connection with the YES Bank fraud case.

A Bench led by Justice Sanjay Kishan Kaul while staying the Bombay HC's August 20 judgment, said that it would examine the legal issues involved in the bail plea. It said that the legal questions that remained pending must be re-examined.

Bail was granted on a technical ground after the agency failed to file a prosecution complaint (equivalent to a charge sheet) within the stipulated period of 60 days.

But, Wadhawan had not been able to come out of prison as they were booked by the Central Bureau of Investigation (CBI) for the same money laundering case registered against YES Bank co-founder Rana Kapoor.

DeepTik has carried out trials in two large hospitals in Mumbai and Pune - the two worst Covid hit cities in the country. Trials began in May 2020, and after successfully analysing 3,000 Covid-19 positive cases, the company is now launching the product in the market.

DeepTik is a two-year-old company founded by Anil Patil, Dr Anil Khairat and Anandh Pant. Khairat is a radiologist, Patil is a serial entrepreneur and alumna of IIT Khargpur while Pant is a data scientist with a PhD from Berkeley.

It is amongst very few radiology companies to translate its technology in a commercial model.
