The basic EPS on standalone basis during this period was Rs. 2.08 as against Rs. 12.24 in 2020-21. The EPS on consolidated basis stood at Rs. 2.07 in Q1 of 2021-22 as against Rs. 12.51 in Q1 of 2020-21.
