The said companies are in the process of filing certified copies of the Orders with the respective Registrar of Companies, West Bengal and Chennai. Pending such filing, no effect has been given in the above financial results of Florence. On filing of these orders, with the respective Registrar of Companies, as aforesaid, Florence Investech Limited stands amalgamated with BACL. In consideration of the amalgamation of Florence with BACL and in terms of the Scheme, BACL will issue and allot Equity Shares in BACL to the shareholders of Florence in the ratio of 89 Equity Shares of ₹ 10/- each in BACL for every 100 Equity Shares of ₹ 10/- each held in Florence.
