The Company has also assessed the impact of this whole situation on its Capital and Financial Resources, Profitability, Liquidity Position, Internal Financial Controls, etc. and is of the view that based on its present assessment, this situation does not materially impact these financial results. The impact assessment does not indicate any adverse impact on the ability of the Company to continue as a going concern. However, the impact assessment of COVID-19 is a continuing process, given the uncertainties associated with its nature and duration. The Company will continue to monitor any material changes to future economic conditions.
6) Exceptional Items: In respect of tax benefits due to adjustment of unabsorbed losses and depreciation of erstwhile TTK Protective Devices Limited and TSK Techno Services Limited which merged with the Company, with effect from 1st April, 2012, (shown as Contingent Asset in earlier years), the Company has received the revised assessment orders in the quarter ended 30th September, 2020 and the refund received is accounted as follows:
(a) Rs. 809.79 lakhs towards Interest on Tax Refund received is treated as Exceptional Income; and
(b) Balance Refund received (net of certain provisions considered necessary amounting to Rs.999.74 lakhs) of Rs. 1,964.81 lakhs has been accounted as Tax Refund relating to earlier years.
7) The Code of Social Security, 2020 (Code) relating to employee benefits, during employment and post-employment, received Presidential assent on 28th September, 2020. The said Code has been published in the Gazette of India. However the date on which the Code will come into effect has not been notified and the rules for quantifying the financial impact are yet to be framed.
