Govt to carry out Aadhaar authentication of prisoners, their visitors

NEW DELHI, NOV 3 /--/ All prisoners and their visitors will now have to undergo Aadhaar authentication following the central government's fresh initiative to strengthen the safe and secure custody of the inmates besides ensuring them delivery of entitled benefits. In a communication to all state governments and union territory administrations, the Union Home Ministry has conveyed that the National Informatics Centre (NIC) and ePrisons team have prepared a Standard Operating Procedure (SOP) document for Aadhaar linking or Aadhaar authentication of prison inmates and their visitors with ePrisons platform for the convenience of all prison authorities. "State/UT prison authorities are accordingly requested to make use of the facility of Aadhaar authentication of prison inmates and the visitors to prison inmates with a view to strengthening the safe and secure custody of inmates and at the same

time ensuring the delivery of entitled benefits of Aadhaar to prison inmates," it said. However, the Home Ministry said that while doing this, the prison

authorities shall adhere to all relevant guidelines on use of Aadhaar authentication as laid down by the central government from time to time. Early this year, the Union Home Ministry was authorised to carry out Aadhaar authentication of prison inmates and their visitors. The ministry

accordingly issued the requisite gazette notifications on March 6 and respectively. September 29 notifying that the prison departments of the states and Union Territories, are allowed to perform Aadhaar authentication of prison inmates and their visitors.

The National Informatics Centre (NIC)/ePrisons has been registered as a sub authentication user agency for facilitating the process of Aadhaar authentication of prison inmates. (PTI)

Gyanvapi survey complete, ASI tells Varanasi court; gets time till Nov 17 to file report

India on Thursday told a Varanasi court that it has "completed" the survey of the Gyanvapi mosque complex and is granted additional time till November 17 to submit

The ASI was to submit the report of the survey by November 6. Accepting the ASI request for more time to submit the report, District Judge A K Vishvesh passed the order on Thursday, Central government counsel Amit Srivastava said. The court was informed that the ASI has completed its survey, but it may take some more time for compiling the report along with the details of the equipment used in the survey work, Srivastava said. On October 5, the court granted four more weeks to the ASI and said that the duration of the survey would not be extended beyond this. The Varanasi court, on August 4, had granted the ASI an additional month to complete the survey, extending its original deadline (from August 4) to September 4. The court provided another extension of four weeks for the survey work on September 6. The ASI carried out a scientific survey of the Gyanvapi mosque premises, next to the Kashi Vishwanath Temple, to determine whether the 17th century mosque was constructed over a pre-existing structure of a Hindu temple.

The ASI survey had begun after the Allahabad High Court upheld a Varanasi district court order and ruled that the step is "necessary in the interest of justice" and would benefit both the Hindu and Muslim sides.(PTI)
