# SUMMARY OF THE PROCEEDINGS OF THE 35<sup>TH</sup> ANNUAL GENERAL MEETING ("AGM") OF HUBTOWN LIMITED

# A. Date, Time and Venue of the Annual General Meeting (Meeting):

The 35th Annual General Meeting (AGM) of the members of Hubtown Limited was held on Thursday, September 21, 2023 at 11.00 a.m. through Video Conferencing ("VC") / Other Audio - Visual Means ("OAVM"). The Meeting commenced at 11:00 a.m. (IST) and concluded at 11:27 a.m. (IST).

83 Shareholders were present through Video Conferencing ("VC") / Other Audio Visual Means ("OAVM").

# B. Proceedings in brief:

- Mr. Hemant M. Shah, Chairman chaired the meeting in accordance with Article 85 of the Articles of Association.
- The Chairman informed that the Meeting was held through VC / OAVM in compliance with the circulars issued by the Ministry of Corporate Affairs and Securities and Exchange Board of India.
- The requisite quorum being present, the Chairman called the Meeting to order.
- The Chairman introduced the Directors and Executives of the Company.
- The Chairman informed that the Statutory Auditors and Secretarial Auditors attended the Meeting.
- The Chairman addressed the members.
- The Chairman informed that the Report of the Board of Directors, the Accounts for the financial year ended March 31, 2023 and the Notice convening the 35<sup>th</sup> AGM were taken as read as the same had already been circulated to the Members.
- The Chairman informed the Members that the Statutory Registers and other documents required to be placed in the meeting under the Companies Act, 2013 were open for inspection electronically.
- The Chairman informed the Members that the Company had provided e-voting facility to its members holding equity shares as of the cut-off date i.e. September 14, 2023 for voting on AGM resolutions. The e-voting period was kept open from Saturday,

September 16, 2023 (from 9:00 a.m. IST) to Wednesday, September 20, 2023 (upto 5:00 p.m. IST).

- Further, the facility to vote on resolutions through electronic voting system at the meeting was made available to the members who participated in the meeting and had not cast their votes through remote e-voting.
- The Chairman further informed that the Company had appointed Mr. Mihen Halani, Proprietor of M/s. Mihen Halani & Associates, Practicing Company Secretaries as the Scrutinizer for scrutinizing the remote e-voting as well as e-voting at the AGM in a fair and transparent manner.

- The Chairman thanked the shareholders for attending the 35th AGM of the Company and declared the meeting as closed.
